life like its ok for all but it's not. They interview all the NAC folks from the past and present trying to gather something that's going to make them millionaires. This holy medicine came through a vision and a prayer. The dominant society, corporate America, is never going to know about it, understand it, or believe it. If it was intended for them then it would be easy but how long has this vibe and energy been going on? The Holy medicine is taking care of itself. It's man that's abusing it. This kind of energy has been going on for years. You see it all over YouTube and social media, but nobody is speaking up or making efforts like NACNA is doing today. Like my Uncle Joe Fish Dupoint, Kiowa Nation, said at the Congressional field hearing in Oklahoma City 2022, they tried to conquer us in the 90s but we all rallied up back then. We can all rally up today make that unity effort like the elders before us did during the Smith case. NACNA is encouraging all members and chapters to be in harmony and in tune with the challenges we're facing today. If you're really for this way of life, let's see it and hear it NAC families! Put some statements out there like news articles, Facebook postings, and conferences. We need all the support. We all need to be in that big tipi where it's wonderful and beautiful for us all.

NACNA has 10 Navajo Chapters affiliated so we try our best to voice and advocate for their rights and voice their concerns. Our prayer and song is that the Navajo Nation president and delegates take that time to really read up on the challenges and the efforts of NACNA boots on the ground for our way of life. We all know there are a lot of chapters and members in the southwest area that's why NACNA has been out there few times already advocating, sharing the concerns and today's challenges. We were in Farmington, NM in 2022; in 2023 the NACNA Convention was held in Gallup NM; and a session at San Juan College in 2024.

We have tribal leadership support and resolution support from these regions and are thankful to all of them: ◆United Indian Nations of Oklahoma, ◆National Congress of American Indians, ◆Rocky Mountain Tribal Leaders Council, ◆United Tribes of North Dakota, ◆Affiliated Tribes of the Northwest Indians, ◆Great Plains Tribal Chairmen's Association, Inc., ◆Coalition of Large Tribes, ◆Great Lakes Inter-Tribal Council, Inc., ◆Wyoming/Arapahoe Tribal Nation, ◆Shoshone-Bannock Tribes, ◆Oglala Lakota Nation, ◆Chippewa Cree Tribe of Montana, ◆Ho-Chunk Nation of Wisconsin, and ◆Mandan Hidatsa Arikara Nation.

**NACNA** is Advancing Spiritual Sovereignty Through Prayer, Direct Action, and Unity. NACNA is in its 76th year celebrating the 30 Years of AIRFA. This fall there will be a Peyote Summit in Washington D.C. November 18-20, 2024 (save the date relatives). Details will be out by mid-September when speakers are confirmed. I encourage all to read up on all the NACNA efforts. We are so thankful to the organizations that are advocating for the protection of the holy medicine and being in tune with the challenges today.

In closing there is lots more I want to shine light on and address, but I will go into more detail in my August Report. Keep in mind relatives that NACNA opposes all decriminalization of peyote/mescaline. You can oppose decriminalization of peyote all you want but in the same breath not understand mescaline is the money maker. So why not put it all out there . . . mescaline is the holy healing spirit of the medicine.
