Did you know.....

JAMES MESHECK LEWELLING 1841-1935

Last member of Abraham Lincoln's bodyguards to die. He is buried in Friends Cemetery.

He watched over the body of the fallen president as Lincoln's body lay in state at the state house in Indianapolis. His friends in Newberg knew nothing of his Civil War service. He always stated that "he wanted no glory for himself," and gave his pension check each month to the American Bible institute in New York City. With his brother he started the first nursery on the Pacific Coast in Milwaukie. They pioneered the development of a variety of cherries: the Black Republican, the Lewelling, and the Bing, which took first prize at the World's Fair. When he moved back to Newberg, he petaled around town on a bicycle, avoiding the new-fangled contraptions known as automobiles. He died at age ninety-four.

2025 ANNUAL FINANCIAL REVIEW REPORT - by Teri Council

March 2025, we conducted our annal Edward Jones investment review meeting with Heath Cornick; Fernwood's account manager. Heath reviewed our goal of "long-term investment" and we discussed how we want to safely grow our cash flow long term too. We have a mix of stocks and bonds in the Franklin family in the low/medium risk category. At our annual meeting we can discuss if we want to change the mix. Right now, we have 45% bonds and 55% stocks mix. Heath also talked to us about thinking about our balances each year as unofficially "endowed," meaning we don't really look at it as, "available/don't touch the principal," but more as an investment growing "more" each year. This is a safe-unofficial way to manage the money without having the formality of it being officially "endowed."

We took advantage last year of the Edward Jones money market fund paying on average 4.8%-+/- and moved \$10,000 surplus from our checking to the fund. Good news is this fund grew with a net amount now of \$10,344.97. The interest rate is tied to the federal interest rate.

Stocks and Bonds are still strong. Edward Jones projects our cash flow for 2025 will be approx. \$1300.00 Heath explained we only pay a handling fee when we first invest. Once we own, we do not have a cost to move the money around. The handling fee is based on the total amount of investment we have with Edward Jones. So, right now we would pay 4.5% based on our investment amount total of \$52,585.86 (in the above \$50,000.00 category). We discussed Fernwood has no known projects in the future so it would be best to move over the "cash gained" from mutual fund growth this past 9 months along with any excess from our US Bank checking account to our Edward Jones stock/bond funds to see more growth with our investment this next year. Michele Crisman, our Fernwood Treasurer, will have the exact amounts to propose at our Fernwood annual meeting on May 17, 2025.

WE LOVE AND APPRECIATE FERNWOOD FAMILY STORIES

Wallace Edgar Jones, 1893-1980, and Ruth Frances Jones, 1894-1989 - as told by granddaughter Sharon Jones Grischow Lucas

Wallace Jones (Grandpa Jones) married Ruth Frances Des Noyer, (Granny) in 1919.

Grandpa and Granny lived in Newberg and other Oregon locations before finally settling back in Newberg. According to notes from Granny's "Memories of Ruth Jones," written about 1976, their first home was on 40-acre homestead five miles northwest of Willamina, Oregon where they built a two-room cabin, a barn and outhouse. Granny moved temporarily in 1920 to Newberg, where Viola was born. They left the homestead and moved to Eugene in September, 1921, where Grandpa went to school at the Eugene Bible College. Wallace graduated in 1922, becoming a minister serving many churches throughout Oregon.

The family moved to a church in Creswell, Oregon, for two years. Their son, Ralph, was born in 1923 in Creswell. Wallace bought a bicycle in Creswell and rode 12 miles to and from school in Eugene each day. He bought an old Chevrolet after nearly being run over by an Adventist minister. They then spent a few years in Lexington and Helix, where Grandpa served at their churches.

Granny again returned to Newberg in 1927, where my mom, Cleone, was born. They stayed a few months in Newberg and then moved to the church at Halfway. Granny's notes end with their move to another church in Hermiston. Eventually, the family returned to live in Newberg.

Both Grandpa and Granny are buried in Fernwood with many other Jones family members. (Row 7, Lot 42S and 43S)

He had so many talents, including writing a notebook titled: "Memories of Early Twentieth Century Rural Life Newberg Oregon, Wallace E. Jones 1975". The notebook is available at George Fox University and can be googled for more information **Wallace E. Jones Memory Book - Archives West.** In it, Grandpa says he "decided to write a brief memory of the physical characteristics of the land, and the life of the people, which lived near Newberg, Oregon, at the opening of the 20th century."

Excerpts from Grandpa's booklet...

The area of Newberg was homesteaded near the middle of the nineteenth century. "Some of those who took up donation land claims included David Ramsey, John H. Hess, W. M. Jones, D. D. Duekin, Oliver J. Walker, Richard Everest, Solomon Heater, Sebastin Brutscher, Luke McKern, Jesse Parish and John J. Hash."

Wallace was born March 18, 1893. There were six children. "Our father was Robert E. Lee Jones. Our mother was Christina Luvina Jones. Four of the children are living. They are Wallace, Noah, Harold and Gladys Beckly (Jones). Two of the children have died. They are Daniel Jones and Opal Howard-Jones."

"We lived on a little farm of twenty-two and one-half acres. The little place was located about one- and one-half miles east of the center of Newberg." [Their farm was on Springbrook Road, south of Hwy 99. Uncle Noah's home was next door.]

Wallace began his schooling in the country school called Brutscher School. In 1900 it was listed as District No. 59. "This school was located on the south west corner of the Brutscher Donation Land Claim. Jennie E. Jones was the teacher that year. The School Board was David Jones, Ruben Everest, Charley Jones, and Tomas Parrish." The students were: Claud Lane, Ola Lane, Lucis Lane, Estil Jones, Emery Jones, Daniel Jones, Wallace E. Jones, Vivian Hadley, Cecil Hadley, Eva Hadley, Garnet Woodworth, Lold Booth, Lee Renne, William Heater, Susie Everest, Elmer Everest.

In 1904, the Brutscher School was listed as District No. 32. The School Board was Walter Everest, Tomas Parrish, Henry Livengood and Lee Jones. The pupils listed that year were: Sophia Fisher, Fannie Fisher, Mary Hobson, Lena Hobson, Lold Booth, Elmer Everest, Bessie Baker, Lizzie Baker, Hary Baker, Ellis Baker, John Conrad, Earl Conrad, Almeda Conrad, Wallace Jones, Emery Jones, Estell Jones, Daniel Jones, Opal Jones, Ruby Jones, Rodney Hobson, George Hobson, Verne Hobson, Anna Peters, Charley Peters, Curl Orton, Louis Hepp.

As the population increased, the school district voted in 1906 to consolidate and build a new two room school building. Wallace's father, Robert E. Lee Jones, working with Franklin Jones built the new school and were paid \$1,455.

Wallace's notebook, written when he was about 82 years old, ends with: "I realize that I have waited too long to write these brief memories. My hands are shaky and I find it very hard to organize my thoughts. Yet I so hope this will preserve life as lived in the early 1900."

My Grandpa Jones was a renaissance man and a devout Christian with a good sense of humor.

Grandpa was a carpenter learning the skill at a young age of 11 or 12. He helped his father build their second home off Springbrook Road, in the Fernwood area due to their growing family. My Grandpa learned all the skill required to build a home, including his and Granny's cabin near Willamina, as well as additions to some of the church buildings where Grandpa served.

Grandpa helped my dad build our 3-bedroom family home in 1955 in Damascus Oregon. Later my dad helped Grandpa tear down an old school in Dundee. They reused much of the lumber to build a home for my Grandparents in Newberg for their retirement. My parents purchased Grandpa's old homestead on Springbrook Road to allow my grandparents to relocate. The home was later torn down and the land sold.

When Grandpa grew up in the family's home built on Springbrook Road, there were so many trees everywhere. There were 40 acres of oak trees very close together where the kids could go from tree to tree without touching the ground. Later, Grandpa built a treehouse in a wonderful oak tree in the backyard for us grandkids to play in. That tree also had gym rings that Grandpa used for doing flips when he was over 70 years old.

Grandpa always liked to keep busy and learn new things. In addition to writing, he started painting with acrylics; built furniture; did bead work and made jewelry. He learned how to crochet, knit and made hooked rugs. Crafting and being creative is in the Jones' blood. My Mom, Cleone Jones (Grischow), loved to do all things creative, sewing, knitting, quilting, painting, and gardening. My sister, brother, myself, our niece and now my great niece love doing anything crafty - It is in our blood.

My grandparents loved visiting with family and friends. I remember the Jones-Schuck annual summer picnics that we attended starting while we were young kids though none of us kids understood what the relationship was between the families.

Fernwood Cemetery is the final resting place for many of our Jones side of the family. My husband, Dave, and I both feel the cemetery is special and we will be honored to be buried there. Our son, Eric, is already there, having passed away in 2021. Eric's gravesite is close to the bench dedicated to Doris Huffman, and the large tree that reminds us of Grandpa and Granny Jones' home on Springbrook.
