**DECLARATION OF MICHELLE BOLOS**

I, Michelle Bolos, declare as follows:

1. I am an attorney at law, duly admitted to practice before the Courts of the State of Illinois and the United States District Court for the Northern District of Illinois. I am one of the attorneys for Bala Bangles, Inc. ("Bala" or "Plaintiff"). Except as otherwise expressly stated to the contrary, I have personal knowledge of the following facts, and if called as a witness, I could and would competently testify as follows:
2. I hereby certify that the Defaulting Defendants (as defined in the accompanying Memorandum) were served on November 1, 2021 and November 17, 2021 via email and electronic publication pursuant to this Court's order, Dkt. 21.
3. I hereby certify that Defaulting Defendants have failed to answer or otherwise plead in this action within the allotted time in violation of Federal Rule of Civil Procedure 12.
4. On information and belief, Defaulting Defendants do not have active military status such that they are unable to appear and defend this action. I base this conclusion on the fact that

Defaulting Defendants reside in China and appear to be private companies, and therefore are ineligible to serve in the United States military.
