FILING AN ASSUMED NAME CERTIFICATE

A company doing business in Texas must file an assumed name certificate (D.B.A. or 'doing business as') with the County Clerk of each county in which the business will be conducted. Assumed name certificates are good for 10 years from the date of filing.

<u>NOTE:</u> Filing an assumed name certificate does not prevent another party from using the same name. In the event of duplicate filings all legal questions arising from conflicts between companies will have to be settled through the judicial system.

The withdrawal of a partner or abandonment of an assumed name is recorded in the same office.

THINKING ABOUT OPENING A NEW BUSINESS?

Basic steps to starting a business:

- 1. File an <u>unincorporated</u> assumed name (D.B.A.) certificate with the County Clerk in the county/counties where the business is located and/or will conduct business.
- 2. Corporations and incorporation documents are filed with the **Secretary of State in Austin 512-463-5555**. Forms and information are available on the Secretary of State's web site: www.sos.state.tx.us/corp/index.shtml.
- 3. To obtain a state sales tax ID #, contact the **State Comptroller** at the LBJ State Office Building, 111 East 17th Street, Austin, Texas 78774, **512-463-4865 or 800-252-5555**. Forms are available on the State Comptroller's web site: www.cpa.state.tx.us/taxinfo.sales/new_business.htm.
