Mayor James Sullivan presented the Blount County Christmas Parade on December 9th. The chamber has asked for all municipals to be involved.


A motion was made by Donna McDougal and Tommy Swindle seconded to attend the Blount County Christmas Parade. Motion passed with majority vote.


At 8:22 return from Executive session. Meeting Called to Order by Mayor James Sullivan
