Ordinance Establishing the Qualification Fee.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF CLEVELAND, ALABAMA AS FOLLOWS:

Section 1. A qualification fee in the amount of \$ 50.00 is hereby fixed and imposed upon all candidates seeking election as mayor of the Town of Cleveland, Alabama, except as hereinafter provided for.

Section 2. A qualification fee in the amount of \$ 50.00 is hereby fixed and imposed upon all candidates seeking election as council members of the Town of Cleveland, Alabama, except as hereinafter provided for.

Section 3. Such qualification fee shall be paid to the Town Clerk and deposited to the general fund of the Town at or prior to the time of filing qualification papers by any such candidates.

Section 4. Any person desiring to qualify who is not financially able to pay the required fee may qualify provided such prospective candidate furnishes the clerk with an affidavit stating that he/she is financially unable to pay the required fee fixed by this ordinance.

Section 5. This ordinance is adopted pursuant to Section 11-46-2 of the Alabama Code of 1975 and shall be effective in all elections, both general and special, for aforesaid offices and after the date of adoption.

2025-03 ORDINANCE TO ESTABLISH THE USE OF ELECTRONIC VOTE COUNTING SYSTEMS

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF CLEVELAND, ALABAMA, AS FOLLOWS:

WHEREAS, Chapter 7 of the Code of Alabama 1975, and the regulations adopted pursuant thereto by the Alabama Electronic Voting Committee, provide for the use of Electronic Vote Counting Systems; and

WHEREAS, Section 17-7-21 of the Code of Alabama 1975 provides that a municipality may in its discretion, by adoption of an appropriate ordinance authorize, adopt, and direct the use of electronic vote counting systems for use in all elections held in such municipality.

NOW THEREFORE, BE IT ORDAINED; that for all elections held in the Town of Cleveland, Alabama, subsequent to the passage of this ordinance, the Town shall use the **AutoMark Ballot Marking Device and the DS 200 Tabulator**, the vote counting system currently used by Blount County, Alabama for county elections, a system which complies with §17-7-21 of the Code of Alabama and any regulations adopted pursuant thereto, is hereby authorized for the reporting, counting, and tabulating of any and all election results.

BE IT FURTHER ORDAINED that the Mayor of the Town of Cleveland is hereby directed to file a copy of this ordinance with the Secretary of State as provided in Section 17-7-21 of the Code of Alabama 1975.

This Ordinance shall become in effect upon its adoption and publication as required by law.
