**ORDINANCE AMENDING THE ORDINANCE REGULATING THE SALE AND
DISTRIBUTION OF ALCOHOLIC BEVERAGES WITHIN
THE TOWN OF CLEVELAND, ALABAMA**

WHEREAS, the Cleveland Town Council met on Thursday, September 14, 2023, for the purpose of discussion of and consideration of a proposed change in the authorized hours set forth in the Town's Ordinance Regulating the Sale and Distribution of Alcoholic Beverages (Alcohol Ordinance); and

WHEREAS, the Cleveland Town Council voted to suspend the rules for immediate consideration of the Amendment of the Alcohol Ordinance; and

WHEREAS, the Cleveland Town Council unanimously approved the proposed Amendment to the Alcohol Ordinance as hereinafter set forth.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Town Council of the Town of Cleveland, Alabama, that Article IX of the Alcohol Ordinance for the Town of Cleveland, Alabama, be amended to read as follows:

"Article IX - Authorized hours.

It shall be unlawful for any person, whether liquor, wine, beer licensee or not, to sell, offer for sale or to serve or dispense for reward or offer to serve or dispense for reward, any liquor, wine or malt beverage during the follow times:

- (1) Between the hours of 12:00 a.m. and 6:00 a.m. on Monday, Tuesday, Wednesday, Thursday, Friday or Saturday of any week.
- (2) Between the hours of 12:00 a.m. and 10:00 a.m. on Sunday of any week.
- (3) The beginning of any day in which an election is being conducted in the Town and the time of such date fixed by law for the closing of the election polls in the Town (i.e. 12:00 a.m. through the time of the closing of the polls.)"

All other terms and conditions set forth in the Alcohol Ordinance remain in full force and effect unless amended herein.
