## 2018/2019 Revenue

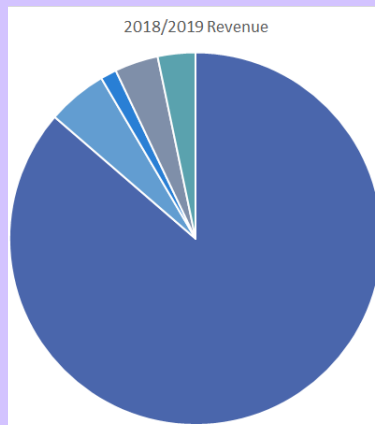

## 2018/2019 Expenses

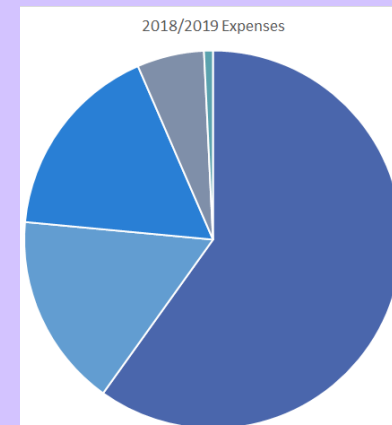
Counseling, Support and Advocacy 60%
