#### **Booth Participation Commitment:**

All vendors are expected to remain open and engaged for the full duration of the event. We encourage your participation at our event.

#### Cleanup & Departure:

Vendors are required to fully clean their space. Any remaining debris, products, or trash must be removed. A Safe House Incorporated is not responsible for any lost or left-behind items.

#### Food Vendors:

Must provide all necessary permits and adhere to local health and safety codes. A copy of your permit may be requested upon check-in.
