MPR General Meeting January 10, 2024

Meeting called to order by John Grigg at 7:36pm

Moment of silence for Holly Baker and Tom Clark who have recently passed away.

Old Business:

Motion made to accept minutes by Rick Falcinelli, seconded by Adam Justin. All in favor

Treasurer's report given by Nancy Spanich in Mario's absence

Withdraw -2/ Deposits -2

Motion to accept Treasurer's Report made by, Dave Muczinski made a motion to accept, 2nd by Rick Falcinelli – all in favor

Welcomed new faces and our Inboard Chair, Tim Collins

Nancy gave membership: Total 82 member for 2024 so far

Steve Linn made a motion to accept Membership Report and Dave Muczinski seconded the motion, all in favor.

Publicity – Tina is still recovering from her surgery and could not make it. No report.

Entertainment: Ray – Steve Read put together a comprehensive report on marketing and will present it to the membership.

IRC – Timmy Collins – National Meeting in 2 weeks. Talked about the IRC having more contact with race sites, few rule changes... most are not real impactful. The top one is life jackets...50/50 split on people across the country that actually wear lifejackets. Spoke about a group of flatbottoms coming back to our category but they will not be racing with inboard. Timmy will have more info at next meeting.

Dave asked if there was any more info about drones. Timmy said it has been challenging but he feels they need to be mandatory. His concern is how to do it without a lot of cost. Approx \$3,500 per weekend...hopefully we can offset that so that the race does not have to pay the whole fee. Sarah suggested sponsorship. Might be easier for the East Coast than the west coast who has more races. There will be recaps of each race within a couple of days on you tube, etc.....

New swag – Dillon will still take orders

Autorama – entry deadline 2/2....late fee of \$25 after 2/2.

John suggested that other people step up to do things instead of having all the same people over and over again.

John talked about the drop in boat count on Sunday's at races. Does not look good on us and will not help the sport grow.

Steve Read said that he has some handouts leftover from Autorama and asked if we want to use them. Sarah will update the flyer for this year.

The Challenge Series will not happen. IRC is working on a new plan for a series.

Driving School – Tony is looking for help. Tim said that a place is needed to store the driving school boats. Tom can store one, can pay for another, but needs another option. Would like to keep them all together. Need someone to bring the student boat back from Region Meeting and a place to store it, hopefully permanently. Ray and John presented Steve Read with the Prop Rider of the year award. Steve thanked everyone. Apologized for his absence recently. Would love to help with more things now that he is retired.

Bylaw Proposals, both proposals submitted by Phil Goodell passed.

Proposed motion to amend Article III Section II of the Marine Prop Riders By-Laws (Election of board positions) – Motion made by Rick Falcinelli, seconded by Adam Justin. All In Favor. Motion Passed.

Proposed motion to amend Article VII Section I of the Marine Prop Riders By-Laws) change wording from Co Sponsor to Conducting Club. Motion made by Austin Hayes, seconded by Dave Muczinski - Majority in favor, opposed, Steve Linn. Motion passed. Steve Read went over a lot of marketing materials.

Not Present: Ray, Mario, and Tina Called to order, John Griggs 6:15pm

John said Steve Read asked about pursuing Waterford. Discussion followed about Mott/Waterfor conflicts, the advantages/disadvantages of both, dates, Sunday race issues that we always have, support from race teams, record vs non-record, etc... Mott becoming a record course could be a plus. Mott owns the land around the course...no residents, and White Lake has said they do not want to give up prime boat season to us. Explained the various different things that we would like to see on the website. We explained all that we are looking for and what may be involved. 




