TO PROCESS APPLICATION

- Pay \$50 nonrefundable fee (no personal checks)
- Submit proof of income

INCOME & RENTAL HISTORY

- Monthly income 2 ½ times the rent
- Great rental history

ANIMALS

- IF pets are approved on the property, there is a \$500 nonrefundable pet fee. Some owners will ask for additional pet rent. Breeds that are restricted are Pitbulls, Staffordshire Terriers, Doberman Pinschers, Chows, Rottweilers, Presa Canarios, German Shepards, Great Dane, Akitas, Siberian Huskies, Wolf-hybrid and any mixes of these breeds.

APPLICATIONS MAY BE DENIED FOR THE FOLLOWING:

- Rental history with late payments, broken leases, eviction, outstanding balance owe to a landlord
- Charged off/unpaid utility accounts
- Felony convictions for crimes against persons or property
