The Indiana Department of Correction is pleased to announce that **Warrick** has been awarded grant funding for fiscal year 2019 in the total amount of \$ **250,334**. The award breakdown is as follows:

Each agency receiving funding must ensure a state grant fund and project income account are established with the county auditor's office, in order to deposit the monthly payment, which will be sent via electronic fund transfer (EFT). Please work with your auditor regarding appropriate fund distribution for each agency.

When payments are disbursed in July 2018, the agency or agencies will receive a 25% advance of the awarded amount. After the 25% is deducted, the remaining funds will be divided into 12 monthly payments. The first monthly payment will be distributed in July as well.

The contract will be sent electronically to the person legally able to sign a binding contract with the State of Indiana.
