

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to 273 Town street and Gineva Murano Glass Jewelry and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Gineva Murano Glass Jewelry include 273 Town street. The Gineva Murano Glass Jewelry website is a Retail Jewelry site. By using the Gineva Murano Glass Jewelry website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Gineva Murano Glass Jewelry may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

## Sharing Information with Third Parties
