It was clarified that we do not need a 3 yr plan. Only an assessment each year of current AIS in order to determine that years action. Items discussed: Make a plan that is flexible. Survey should be done soon after ice out. Look at one year's results to go into the next year's growth survey. TLID will let James Johnson know what areas of concern we want him to check when he does his survey.

## **New Business:**

Grants: the DNR will again be offering grants for AIS control. Scott will check with Lake Management on possible DNR Grants.

Assess Cameras: the TLID will be getting info about assess cameras that Big Lake is currently using. We will look at a possible product presentation sometime during a winter meeting. If feasible this would be presented to the members at the annual meeting as a project since it was brought up at the 2019 annual meeting.

Discussion was held about the Weis property on Elk Lake as there are many possibilities for its use. Nothing definite has been decided by parties involved.
