Old Business:

Warning signs on Rush spillway: Who's responsible? Possible add reflectors or paint to posts. Scott will contact Sherrif to see about adding buoys. Anything attached to the posts must be limited so as not to put pressure on the posts or to impede water flow. The TLID will not take any responsibility for any signage put on spillway.

James Johnson update: James will be sending out quotes for next years contracts.

Weis Property Update: The county is still interested in purchasing the property as a park.

Assess Cameras: Nancy H reported that she has been in contact with Erik from I-LID about coming to the TLID meeting in Jan to give a presentation. They supplied the Big Lake cameras being used. The report from Big Lake is that they like the cameras but are disappointed in the I-LID service. The DNR has decided that they will NOT prosecute on any information taken with the cameras. There are also concerns as to how much data is collected and who will be reviewing that data. The cameras are removed during the non boating months each year. There will also need to be a discussion as to who is responsible for calling on violators that are found on the videos. It was decided that the CD3 decontaminate system is too expensive for the TLID to explore.

Grants: The SWCD Grant for 2020 is due in January. The TLID will again be going for approximately \$4500.00 in grants. This will be our third year to apply. Lake Management will be applying for the DNR grant.

Water Stabilization 2.0: Funding has been secured to go to next step. SWCD will commit to \$5000.00 with the TLID and BLCA splitting the remainder.(approx \$12,000.00) Dan C from SWCD will be the project manager and Wenck will be supplying data. Lou Zang is the Wenck contact. Dan has been having difficulty in contacting the owner of the Bayou land where the water over flows from the Elk River.

New Business:

Possible Goals for 2020: Discussion was held as far as goals for the TLID. Kenzie and Scott will present possible goals for the TLID at the Jan meeting.
