## Officer Reports:

**Advisor**: Sherburne Cty Commissioners will be voting at their next meeting on whether to continue supporting the Elk River Watershed or move to the DNR recommended Watershed. It appears they will be leaving the Elk River Watershed. Benton Cty is not on support of leaving the watershed. A TLID director could be part of the new advisory board on the new watershed.

## **Old Business:**

SCWD – Mike Flanery, Gary Anderson and Walt Munsterman participated in a training class for water testing at the Bayou Bridge on Hwy 16. There will also be water flow testing when the water is moving. This is part of a MPCA program.

Lake Spraying – Lake management recommended 20 acres of spaying after their survey. TLID wanted to be closer to the 51 acres done in 2018 and told Lake Management to submit a bigger area. The DNR came back and allowed 11.3 acres after Chris Jurek took some sampling of weeds. The TLID is not allowed to spray within 150ft of shore without permission from the land owner. We could if land owner ops out. There appears to be new areas of CLP this year than in past years. (north end of Julia).

Discussion: Should we do a survey earlier in the summer? What study will the DNR except? Get a plan to the DNR early so we can amend if not excepted by the DNR. Point Intercept Study will continue on Julia for 2019. Get plan to DNR no later than this fall.

### **New Business:**

Discussion on annual meeting - Looking at doing a complete survey that would be good for a three year plan to the DNR. More money in the budget will be but in for this purpose. \$15,000.00

Letter will be sent out the end of July for the annual meeting. Forms and budget were discussed and will be finalized at the Aug meeting. The TLID will consider 2 budgets with one allowing for a review and exploration of a berm to be added in the Bayou where the water over flows from the Elk River. \$10,000.00 was discussed. Scott will contact Dan C from SCWD to get his input on the berm. The TLID will also look at possible multiple budgets to present at future annual meetings. This will give members and idea of what the assessment will be on different projects.
