**Grant Update:** Scott has submitted an application for a grant from the SWCD towards the treatment of weeds. He is watching for the DNR application to open and will apply when available. We will be able to use only one grant but by applying for both we have a better chance of being awarded one.

**James Johnson Update:** Mike reported that James sent the approved Curly Leaf Pondweed spraying map to Lake Management. Lake Management verified that they received it and will apply for the appropriate permits.

**Weise Property:** The county held a informational meeting at the landing of Elk Lake Saturday to get questions and suggestions from residents. There will be another opportunity this spring for residents to voice their concerns, suggestions and questions. **Wenck Update:** Mike looked at placing a broad crested weir before the inlet (as recommended by the Wenck report) and what would happen regarding the rate of flow if the opening coming in at the bayou was smaller than the opening at the outlet on Rush. Mike will contact Dan regarding this and ask Dan if he would be willing to present the Wenck findings at a future meeting to our members (possibly virtually).

**Elk Lake TLID Update:** Scot and Kenzie are planning on meeting with an Elk Lake representative next week and will report back to us in March.

**New Business:** Mike shared an email regarding an upcoming AIS Management 101 Course. This is an online course from the U of M. Board members should consider taking this self-paced course to get a better understanding of AIS management strategies and to be better informed consumers of management programs. The cost for the course is \$75. TLID has money budgeted for training.
