Tree Identification, Wildlife Habitat, and Invasive Species Meeting

The Sugar Valley Watershed Association held an educational event on Saturday, September 14th on the property of Aaron and Nicole Yohn, which is located behind the Sportsman's Club in Loganton, Pennsylvania.

The key speaker was Dan Heggenstaller, a member of the Watershed Association who is a forester with the Pennsylvania Game Commission. Dan led the group of close to 20 attendees through the woods and fielded many questions along the way. His presentation included invasive species identification and methods on how to control them, tree and habitat food source identification, different ways to improve the wildlife habitat, etc. He discussed timber harvests and how they affect plants and animals as well as how wildlife forage and look for cover. He took time to explain that white oak acorns germinate in the fall and red oak acorns don't germinate until spring. He also explained that if there are a great deal of small saplings of other species around the bottom of oak trees, they hinder acorns from becoming established due to lack of sunlight. There were many questions from the participants and the walk through the woods lasted almost 2 hours.

There were also activities for the children who attended. These activities included a scavenger hunt, campfire safety, and coloring books to take home. There were 8 children in attendance.

The Sugar Valley Watershed members who attended were James Harbach, Dan Heggenstaller (Presenter), Coreena Meyer, and Emily Heggenstaller. The rest of the participants were members of the community and some individuals from outside the community who were interested in attending.

There was a picnic that followed where the discussions continued and many questions were asked of Dan.

Sugar Valley Watershed Association

The BFCCA is a stock owner nonprofit represented by the fifteen property owners within the narrow four-mile pass known as the "Narrows."

Sieg Conference Center Update and Big Fishing Creek Cottage Association Review Committee

In March 2020, due to the global covid epidemic, the Sieg Conference Center (SCC) closed. It remains closed and the owner, the Commonwealth of Pennsylvania, wishes to divest this investment. In April 2024, at the BFCCA annual meeting, the membership by adoption agreed to form a membership committee “to continue and engage in discussion” to find an acceptable successor to the SCC.

Since April, a nine (9) member committee was formed. The Committee has met twice by Zoom and was scheduled to meet again on October 28th. Background calls have been held between Attorney Joe Green, President Brown, state attorneys, and facility management staff from Lock Haven - Commonwealth University.

A walkthrough of the SCC was held in September. Several parties have shown interest. As the owner of the building at the SCC, the Commonwealth of Pennsylvania is the primary owner. They remain the primary negotiating entity for agreement and sale.

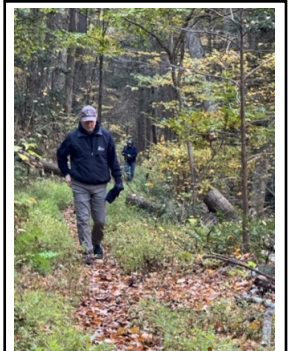
Big Fishing Creek Cottage Association Habitat Management Update

In October 2023, members of the BFCCA, PA Fish and Boat Commission (PABFC) and the Clinton County Conservation District (CCCD) met to consider stream habitat improvements in the Big Fishing Creek Narrows.

Five improvement sites were selected and site designs were prepared by PABFC. In Spring 2024, the CCCD, deferred consideration for funding due to the lack of a local match. Request for funding will be reconsidered in Spring 2025.

SGL 295: A Natural Buffer for the Protection of the Narrows

State Game Lands No. 295, consists of 12,336 acres. It is adjacent to and surrounds the BFCCA boundaries. It is the largest one-time acquisition for Pennsylvania state game land and serves as a buffer/infringement against future development.

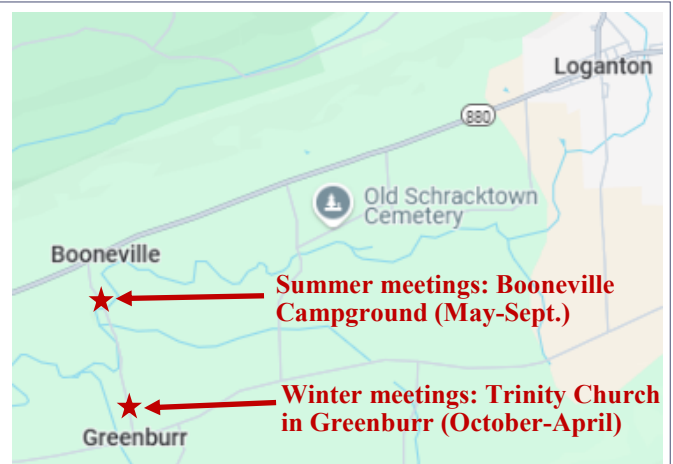
