Thank you very much for your interest in the **IRIOSH Global Occupational Safety, Health & Worker Well-Being Summit 2026** hosted in Singapore on November 11, 2026.

We hope these frequently asked Q&As will help to understand IRIOSH Global Summit in Singapore.

Registration

Q1: What is the registration fee for presenters?

A1: Bank Transfer: USD 100. Credit Card / Online Payment: USD 106 (includes PayPal processing costs).

After submitting this registration form, for Credit Card or Online PayPal Payment -

Participants selecting bank transfer are responsible for applicable bank charges, intermediary fees, and currency conversion costs. Please complete this registration form and ensure to Click on Submit Button, carefully. Your registration will be confirmed upon receipt of payment.

Q2: Are Invited Speakers or Distinguished Speakers exempt from the registration fee?

A2: Yes. Invited Speakers and Distinguished Speakers officially invited by IRIOSH will be **exempt from the registration fee**. Lunch will also be provided as part of their participation.

Q3: Is the registration fee the same for oral and poster presenters?

A3: Yes. The same registration fee will apply to **oral presenters, poster presenters, and general participants**.

Selection

Q4: Are Distinguished Speakers by invitation only?

A4: Yes. Distinguished Speakers and Round-Table Forum Panel Members are selected **by invitation only**. This approach enables IRIOSH to ensure that invited presentations align with the Summit theme, maintain programme quality, and provide balanced international representation.

Should APOSHO members/affiliates/supporters decide to participate as a **Strategic Partner, Presenting Partner, Platinum Partner, or Gold Partner**, **IRIOSH would be pleased to work collaboratively with them in identifying suitable Distinguished Speakers and Round-Table participants**. The number of invited speakers and panel opportunities **would be determined jointly during programme development**, taking into consideration the agreed partnership package, overall programme schedule, and balanced international representation.

Q5: Is there any limit on the number of presenters from one organisation?

A5: There is no fixed limit on the number of abstract or poster presentations submitted by a single organization. We welcome multiple submissions from APOSHO members/affiliates/supporters. All abstracts-



will undergo the IRIOSH Editorial Peer-Review Process, and final acceptance will be based on scientific quality, relevance to the Summit theme, and programme capacity.

Fees

Q6: Besides the registration fee, are there any presentation, publication, or administration fees?

A6: No.

IRIOSH does **not** charge separate fees for:

- Abstract submission;
- Oral or poster presentations;
- Publication of accepted abstracts in the official Conference Proceedings; or
- Administrative processing.

Similarly, participation in the **IRIOSH Global Book Chapter initiative** is entirely separate from the Summit and **there are no contributor or publication fees** associated with the Book Chapter project at this time.

Event Access

Q7: Does the registration include access to all three days of Safety & Security Asia (10–12 November), or only the IRIOSH Summit on 11 November?

A7: The IRIOSH registration provides access to the IRIOSH Global Occupational Safety, Health & Worker Well-Being Summit on 11 November 2026.
