New Business

<u>Loose Dogs</u> - HOA has received an anonymous complaint regarding loose dogs from homes on 270 A. This is a police issue and we advise that you contact the police to file a complaint.

<u>HOA Dues Late Fees</u> – Annual HOA Dues are due the first of each year with a late fee of \$50.00 assessed if paid after March 31st. Dues that are still un-paid by the following year (year two) will be assessed an additional \$100.00 and will have a lien placed on the property with a \$500.00 lien removal fee. Additional late fees will be assessed annually with increases as follows: Year 3 - \$150.00, Year 4 - \$200.00, etc.; all late fees and lien fines must be paid to remove the lien.

<u>270 A Bridge</u> -Two projects for Fall/Winter 2024/2025 to clean up growth around bridge and under bridge to avoid bridge deterioration.
