#### **Old Business:**

Drew Freed has presented a snow removal contract for 2019 and a Certificate of Liability Insurance. This contract was approved by the CBCC Board.

Association members are reminded that the only signs allowed in Crystal Band & Crystal Cove are realtor For Sale signs. Any other type of sign should be removed.

The CBCC Improvement Steering Committee headed by Eric King is still looking for volunteers to start this exciting task force. This committee will be responsible for identifying and presenting to the Board any neighborhood improvement projects that come to their attention. Additionally, they will work to define scope, costs, and sources for funding these improvements.

The Covenants Change vote still has not received enough votes for a 2/3 majority. We would like to remind you that this is an important update for all of us. Board members will be glad to answer any questions from any Association member. It was discussed that a simple majority of all lot owners would be more appropriate than the 2/3 requirement now in place. However, it would take a 2/3 vote to make this change too.
