### **Treasurer's Report:**

#### **Old Business:**

### Weed Control

General discussion regarding the increase of weeds in both Crystal Bay & Crystal Cove occurred. It was brought up that perhaps we should reduce the amount of money we are sending to the Hamilton Lake Association (\$150.00 per lot) and use that money for contracting weed spray for just Crystal Bay and Crystal Cove. It was pointed out that we have access to and are using all of Hamilton Lake. Some lot owners have retained additional weed spray services or DYI on their own to deal with the increase in weed population. Bob Yant will review the weed spray concerns with the Hamilton Lake Association and ask for increased treatment and/or a reduction in weed fees.

### Plat

Eric King will reach out to County Commissioner Jim Crowl to get some direction on what to do to complete and finalize the Crystal Bay & Crystal Cove Plat so it can be officially recorded.

### Covenants Vote

The Board plans on moving forward with securing signatures on the Covenants Changes described on our website at cbcchoa.org

If necessary, Board Members will go door to door to complete this task.

#### **New Business:**

Lot 198 needs to be directed to become compliant with CBCC Covenants with regard to the gravel drive, temporary storage unit, gas tank and dues. The Board will work with the owner to address these issues.

Dick Lineberry will reach out to Nate's Lawn Care to obtain insurance information in line with his mowing contract for Crystal Bay & Crystal Cove.
