1. Information We Collect

We may collect the following information when you use our services or interact with our website:

- Name, email address, phone number, and other contact details.
- Information you share during intake, booking, or service sessions (including written, verbal, or electronic communications).
- Payment details (processed securely by third-party payment processors; we do not store your full payment card information).
- Technical data such as IP address, browser type, and website usage statistics (collected via cookies or analytics tools).

2. How We Use Your Information

We use your information to:

- Provide, personalize, and improve our services.
- Communicate with you about appointments, services, or important updates.
- Maintain legal and regulatory compliance (including HIPAA requirements).
- Improve our website and customer experience.

We will never sell or rent your information to third parties. Information is only shared:

- With your explicit written consent.
- When required by law or legal process.
- With trusted service providers who assist in delivering our services (and who are bound by confidentiality agreements).

3. HIPAA Compliance

We comply with the Health Insurance Portability and Accountability Act of 1996 (HIPAA) and treat all client data as Protected Health Information (PHI). This includes:

- Secure, encrypted storage of records.
- Limited, need-to-know access to information.
- Encrypted email and file transfer for PHI.
- Practitioner HIPAA certification renewed every two years.

4. GDPR & International Data Rights

If you are located in the European Union (EU), the UK, or other jurisdictions with similar laws, you have specific rights regarding your personal data, including:
