Release of Liability and Assumption of Risk Waiver for 2020

In consideration of (Dennis Law) & (Blackwatch Paintball Club) furnishing services/equipment to enable me to participate in paintball related activities/games.

I agree to the follow:

- (a) The risk of injury from activity and weaponry involved in paintball is significant, including the potential for permanent disability and death. While particular protective equipment and personal discipline will minimize the risk, the risk of serious injury does exist.
- (b) My participation in such activities/use of such equipment may result in including but not limited to illness, bodily injury, disease, stains, fractures, partial/total paralysis, blindness, heat stroke, heart attack, death or other ailments that may cause serious disability.
- (c) These risks and dangers may be caused by the family, employees, officers or agents of (Dennis Law) & (Blackwatch Paintball Club). Negligence of the participants, the negligence of others, accidents, breaches of contracts, the forces of nature or other causes. These risks and dangers may arise from foreseeable or unforeseeable causes or circumstances.
- (d) By my participation in these activities/use of equipment/facilities situated at (1370 260th Street Aldergrove, BC V4W 2S1) **I, knowingly and freely assume all risks and all responsibilities for any losses/damages even if caused in whole or part by the negligence or other conduct of the family, employees, officers, agents, of (Dennis Law) & (Blackwatch Paintball Club) or by any other person(s).**

Para. (1) I, on behalf of myself, my personal representatives and my heirs hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify (Dennis Law) & (Blackwatch Paintball Club) and his family, employees, offices, and agents from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of paintball equipment or my participation in paintball activities.

Para. (2) I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the family, employees, officers, or agents of (Dennis Law) & (Blackwatch Paintball Club).

Para. (3) I understand and agree that this **Release of Liability and Assumption of Risk Waiver** covers each and every paintball related activity or event t 1370 260th Street, Aldergrove, BC V4W 2S1 in which I participate from January 1, 2020 up to and including December 31, 2020.
