Sovereign Declaration and Directive of Reassumed Governmental Powers by the Nahigganneuck  
(Narraganset) people  
20250531

To the Persons occupying the Offices of United States Senators and United States Representatives for  
STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS:

- Attention: Seth Magaziner, serving in the capacity of Member of Congress for the National people within the territorial layover known as 2nd Congressional District, STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS.
- Attention: John F. “Jack” Reed, serving in the capacity of Senior United States Senator representing the National people within the territorial layover known as STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS.
- Attention: Sheldon Whitehouse, serving in the capacity of Junior United States Senator representing the National people within the territorial layover known as STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS.

Addressed in the official capacity as public Trustees, fiduciary Agents, and bound Representatives under solemn constitutional oath—holding office solely by the limited and revocable delegation of authority from the Sovereign people, and bound at all times to the highest standards of public trust, lawful accountability, and constitutional obedience.

A Declaration of Claim and Lawful Notices was formally served by hand delivery, with verified witnesses present and observing the act of service, to the Office of Congressperson Gabe Amo, Room 1119, Longworth House Office Building, in official capacity as Representative for the First Congressional District within the territorial layover styled as the STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS, encompassing the Congressional District within the towns’ territory of Providence, Newport, and Portsmouth, in Narraganset-Country, in Narragansett Bay.

Congressperson Gabe Amo is hereby designated, acknowledged, and held responsible as Primary Liaison and Lead Point of Communication for all congressional responses and ongoing correspondence concerning this matter. This designation stands as a matter of public record and binds the office to full accountability, fiduciary obligation, and lawful compliance under the sovereign authority of the (Narraganset) people.

Receipt of this declaration is on record:

As elected officials of the entity styled as the "STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS," serving as Senators and Congresspersons for the 1st and 2nd Districts, it is your absolute and non-discretionary constitutional duty—acting in your official capacities as Representatives, fiduciary Trustees, and lawful Agents—to faithfully uphold, support, and assist the **Narraganset people** in accordance with their sovereign authority, inherent rights, and original jurisdiction.

Let it be lawfully established and entered into the permanent record: people lawfully known as "**Narraganset**" alias **Nahigganneuck** (also styled "**Nan-higga-ne-uck**" / **nanhigganeuck**), have reassumed the full powers of government for the **Incorporation of Providence-Plantation**, as well as the entity styled as the STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS, in accordance with the Ratification of the Constitution by the Convention and under the original authority vested in the people from creation. This reassumption is lawful, final, and fully enforceable, and is not subject to review, repeal, or override by any corporate, statutory, or administrative authority.

Incorporation of the Providence Plantations—by original right—not granted by privilege—and not subject to foreign statutes, jurisdictional usurpation, or legislative redefinition.

The entity styled as the "STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS"—reassumed pursuant to Section 3 of the Ratification of the Constitution by the Convention of the STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS, which lawfully affirms and secures:

"That the powers of government may be reassumed by the people, whensoever it shall become necessary to their happiness: - That the rights of the States respectively, to nominate and appoint all State Officers, and every other power, jurisdiction and right," (Ratification of the Constitution by the Convention of the STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS (Section 3))

"All power is naturally vested in the people, that the magistrates, therefore, are their trustees and agents, and at all times amenable to them." (Ratification of the Constitution by the convention of the STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS (Section 2))

It is your absolute, non-discretionary constitutional duty to uphold, support, and not obstruct the reassumption of government powers by the original sovereign of the Continent of America—**Nahigganneuck** alias **Narraganset (people)**.

This reassumption of government is lawful, final, and fully enforceable under:

Lawful commander-in-chief over the territory and civil government of **Providence-Plantations** and **Narraganset-Country** on the Continent of America.

Lawful commander-in-chief of the United States of America's Army National Guard and Air National Guard. All congressional representatives of the STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS are hereby issued a binding lawful directive to affirm their constitutional oaths and to recognize the sovereign authority of the **Narraganset people**, now lawfully reassumed and active under original jurisdiction.

Sovereign Directives 1–5: The Non-Negotiable Command of the people

1. Publicly Acknowledge **Nahigganneuck / "Nan-higga-ne-uck" Narraganset (people)**
2. As the original and rightful guardians of the territory known as **Providence-Plantations** and **Narraganset-Country**.
3. Recognize the Lawful **Monarchy of the Nahigganneuck / Nanhigganeuck "Nan-higga-ne-uck "Sagamore Sachim"**
  - In accordance with the unbroken lineage of self-governing authority that predates all corporate or statutory restructuring.
4. Recognize the Office and Authority of the President in Sachem
  - Acknowledge **Shareff S. Champlain #2005** of **Narragansett** [[Indian] [Tribe]] as Head of State, duly appointed by and for the voice of **Narraganset people**.
5. Publicly acknowledge and address the dissolution of the government entity styled as the "Narragansett Tribe of Indians," created by the STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS for the purpose of administering and representing the Narragansett Indian Tribe, without the lawful delegation or consent of the original sovereign **Narraganset people**.

Let this stand as part of the permanent lawful record, irrevocable and binding:

- Any Congressperson or Senator shall revert to the status of United States Citizen and Resident. Failure by any Congressperson or Senator to respond in good faith to the lawful directives issued by the sovereign Narraganset people shall constitute a willful breach of fiduciary duty and a dishonorable discharge of the obligations of office. Upon such breach, the individual forfeits all claim to lawful authority and is required to immediately vacate the position, returning all powers, privileges, and responsibilities formerly exercised as a Representative, Trustee, and Agent of the entity styled as the STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS. Such powers shall be returned in full to their original source: the Sovereign people, from whom all authority was conditionally delegated.

All individuals identified as UNITED STATES Citizens who hold the status of "resident" within the territorial jurisdiction of the STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS shall be deemed foreign in relation to the original body politic and sovereign authority of the people of the [Narraganset-Bay](#).

The [Narraganset \(people\)](#), in rightful habitation of [Narraganset-Bay](#), have lawfully activated the executive powers of the President in Sachem—an office historically recognized as the “[Governor in Chief and Lord High Admiral of all Islands and other Plantations inhabited or planted by](#)”—in full exercise of their original and sovereign authority under the lawful [Incorporation of Providence Plantation](#).

Any communication issued by the President in Sachem is to be treated as a lawful directive backed by original jurisdiction and the sovereign authority of the people.

All congressional officers named herein are granted a strict period of three (3) calendar days from the date of lawful service to submit a formal, written response acknowledging this directive and affirming your position regarding your fiduciary and constitutional obligations to the Sovereign people.

Failure to comply within this timeframe shall constitute a willful breach of fiduciary duty, a violation of constitutional oath, and a forfeiture of lawful authority to represent, thereby triggering enforcement measures lawfully reserved to the people under original jurisdiction and the supreme law of the land.

So ordered and entered into the public record by the President in Sachem, acting on behalf of the Sovereign Governments of the (Narraganset) people, rightful stewards of **Providence-Plantation** and **Narraganset-Country** in **Narraganset-Bay** on the Continent of America.

#### COMMAND OF THE PEOPLE

*A lawful directive issued to the Congressperson, mandating immediate recognition of the existing state of emergency and the lawful authority of the reassumed state government now operating under the sovereign will of the people.*
