### Lawful Advisory:

PROVIDENCE PLANTATIONS are hereby lawfully advised that the **Narragansett people**, as the original and  
sovereign authority, have reassumed all governing powers by right and historical record.

Failure to acknowledge, respond, or act in good faith constitutes a willful breach of fiduciary duty and a  
dishonorable discharge of public obligation. Such failure shall result in forfeiture of claimed authority, lawful  
removal by sovereign order, and permanent entry into the public and constitutional record as noncompliant.

#### Right to Alter or Abolish Government – Foundational Principle

"Whenever any form of government becomes destructive of these ends—life, liberty, and the pursuit of happiness—it is the right of the people to alter or to abolish it, and to institute new government..."  
— Declaration of Independence, July 4, 1776

#### Article I, Section 2 — The People Choose the House

"The House of Representatives shall be composed of Members chosen every second Year by the People of the several States..." (Constitution for the United States of America)

The Narraganset people are lawfully recognized and recorded as a sovereign people of Narraganset-Country, in Narraganset-Bay on the Continent of America.

"...of the Towns of Providence, Portsmouth, and Newport in the tract aforesaid, have adventured to make a nearer neighborhood and Society with the great Body of the Narragansets..."  
(Patent for Providence Plantation)

By original right, the Narraganset people hold lawful guardianship and power of the Incorporation of Providence Plantations, without waiver, interruption, or subordination.

The Narraganset people have reassumed the government styled as the "STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS", in accordance with the authority set forth in the Ratification of the Constitution by the Convention of the STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS, which lawfully affirms:

Section 3 – That the powers of government may be reassumed by the people, whensoever it shall become necessary to their happiness... (Ratification of the Constitution by the Convention of the STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS)

Section 2 – All power is naturally vested in the people; that the magistrates, therefore, are their trustees and agents, and at all times amenable to them. (Ratification of the Constitution by the Convention of the STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS)

These provisions affirm that all governmental authority originates solely with the people, and that the reassumption of such authority by the Narraganset people is not only lawful and constitutional, but also binding, irrevocable, and enforceable as a matter of inherent right and permanent public record.
