4. Cancellation and Rescheduling: The Student must provide at least 24 hours' notice for any cancellations or rescheduling of lessons. Failure to provide notice may result in full lesson charges.

- Food and/or chewing gum is NOT allowed in studios. Water is allowed. Please be ready on time for class meaning: hair, clothing, and shoes are on and ready before class begins.
- Students are required to have fun!
- Your instructor will advise what is appropriate clothing for your classes.
- The Studio will be opened 15 minutes prior to first class of the day. Students under the age of 8 are not to be left Unattended before their class starts!
- No running or horseplay in the studio. Although our spacious studios are ideal for children to play in, we want to stay accident free!
- Please do not enter studios before designated class time out of respect for the class in session.
- Parking spaces are limited at our studio, please drop off and pick up students as quickly and as safely possible.

### **Full withdrawal from classes**

If the student decides to stop all classes, refunds for pre-paid classes will be provided if notice of cancellation is received in writing. There will be a \$50.00 administrative charge for full withdrawal.

Statutory Holidays and school break (PA) days are not refunded. If there is a period of extended absence because of severe extenuating circumstances from illness, injury or family reasons The Arts House will not charge for that period.
