### Parental Authorization for Medical Treatment

### Waiver Release

I hereby WAIVE, RELEASE, ABSOLVE, INDEMNIFY, AND AGREE TO HOLD HARMLESS, Manor Area Youth Association (MAYA), it's respective organizers, sponsors, coaches, representatives, supervisors, participants, associated personnel, including the owners of any facilities utilized for the program, and any person working with and/or transporting my child to/from all activities, from any claims arising out of injury or death to my child, whether the result of negligence, or for any other cause, except to the extent and the amount that might be covered by accident or liability insurance.

### Physical Waiver

I, the parent/legal guardian of the participant, agree that it is my responsibility to determine said participant's fitness to participate in any of the opportunities, playing, conditioning and exercising, provided by Manor Area Youth Association.

### Equal Treatment Policy

I understand that MAYA follows a strict policy regarding the distribution of gifts and/or additional items purchased or donated by any Volunteer, Coach or Parent to only a limited number of children participating in any particular sport. The policy regarding distribution of any gift to any participant/cheerleader is that any gifts and/or donated items must be provided for all children participating in the sport. Distribution of any items to only one Individual, Team, Cheer or Drill Team Squad will not be tolerated. MAYA participants must all remain uniform and no additions and/or changes may be made to any participant's uniform nor any additional items, objects and/or props added.

### Fundraising Policy

I understand that in addition to the registration fee, ADDITIONAL COSTS WILL BE INVOLVED. I understand there will be fundraising activities throughout the season.
