The President opened the meeting at 6:00 p.m.

**I. Cheer:**

Registration is \$300 now. I would like to see registration extended to allow more people time to pay. If the girls do not have a uniform in time, they will have to sit in the stands with the pep squad.

**II. Football:**

Sixty-Four (64%) have paid or have paid something. Deposits will be taken at the parent meeting. We have had a few children drop, but we are still at full capacity in Flag and Juniors. We can still fill two (2) spots in Rookie, and we are at 22 in 12U. We may have to cut two (2) Rookie players or ask for volunteers to move up.

Vanessa asked for clarification on the coaches' discretion on Attendance Policy. Demetrius assured her that the rule only applies to "unexcused" absences and tardiness. The announcement of the new policy will be shared at the parent meeting and then shared on the Heja App. Kelvin suggested that we not post it on Facebook to keep our business in house.

Practices will be moved across the street to the high school field to give us more field space for practice. Practice schedule is 6:15-8:15 p.m. We do not have a schedule yet for the season. Hopefully after all numbers are in or registration is over, we will get more information.

We have not acquired any security as of date. Demetrius found out that the standard rate is \$50.00 an hour.

**III. Agenda:**

Jeremy asked if we had an agenda for the parent meeting. He suggested that we use either Shantai or Kelvin's speaker so everyone can hear. He also suggested the following be put placed on the agenda:
