Foster Agreement and Initial Home Inspection

I understand fostering is a temporary arrangement and all cats I foster belong to JJ's Helping Paws. I have read, understood, and signed the Volunteer Agreement and Foster Handbook and will comply with each. _____

I understand the purpose of fostering is to provide care and help the cat(s) adjust to living in a home. _____

I agree to keep foster cat(s) indoors at all times. If there is a doggie door in my home, I agree that it will be kept locked and inaccessible at all times OR the cat will be kept in a closed room at all times. _____

I agree to notify JJ's Helping Paws immediately if the cat(s) becomes ill or lost. JJ's Helping Paws will not be responsible for unauthorized veterinary bills. _____

I understand that rescued or surrendered cats can be unpredictable. I understand that cats in my care may bite, scratch or otherwise injure people, other animals, or property. I specifically indemnify and hold harmless JJ'S Helping Paws, it's board and any other member from liability resulting from any cat I foster. _____

I agree that JJ's Helping Paws is not liable to me, any family member, resident pet or visitor for any injuries, damages, losses and/or medical expenses incurred in connection with fostering cats for JJ's Helping Paws. _____

I agree I will not acquire any additional kittens/cats for fostering without the prior authorization of JJ's Helping Paws. JJ's Helping Paws will not be responsible for any expenses for unauthorized kittens/cats. _____

I agree I will return foster cat(s) back to JJ's Helping Paws if circumstances develop where I am unable to provide care. _____

I agree to periodic home inspections and to provide pictures, updates and information on my fostered cat(s) when requested. _____

I agree to transport the cat(s) at a time and place designated by JJ'S Helping Paws when requested and that transport will be done in compliance with the Pet Animal Care Facilities Act (PACFA). _____

I understand that adoptions by fosters require the approval of the Board of Directors. If approved, I will pay the current adoption fee as set by the Board of Directors. Adoption cannot be guaranteed, especially if the cat has already been promised to a rescue partner. _____

I understand and agree to adhere to all relevant zoning and animal control codes and ordinances, whether local, county, or state. I understand that in compliance with the Pet Animal Care Facilities Act (PACFA), an annual home inspection will be conducted if I am an active foster for JJ'S Helping Paws. _____

I hereby release, and agree to indemnify and hold harmless JJ's Helping Paws, it's agents, representatives, officers, employees, volunteers, assigns and insurers, hereafter referred to collectively as "the Released Parties", from any and all liability, claims, demands or actions or causes of action whatsoever, arising out of damage, loss or injury to my person or property while volunteering as contemplated by this agreement, whether such damage, loss or injury results from the negligence of the Released Parties, their respective agents, officers, employees, volunteers, successors, assigns and insurers or from some other cause. This release and agreement shall be binding upon me, my heirs, successors, assigns, administrators and executors. _____
