☐ **Articulation Assessment** *(how your child pronounces sounds in words, sentences and conversation, oral-motor exam)*- \$450

☐ **Articulation Assessment with Phonemic Awareness Testing** *(how your child pronounces sounds*

in words, sentences and conversation, oral-motor exam) This also includes phonological awareness testing (*how your child is learning sound positions, blending sounds as needed for sounding out words for reading and spelling*) and possibly a hearing screening. This is generally recommended for children with multiple articulation errors ages 4 and up. **\$650**

❑ **Birth-Age 2: Comprehensive Speech-Language Assessment - \$1200** This includes everything: language comprehension and expressive language development, pronunciation, oral-motor exam, social/play and engagement, attention span, getting input from any daycare/preschool teachers.

❑ **Bilingual/Multilingual Birth-Age 2** Additional language exposure of more than 30% in addition to English requires additional time to properly assess/compare languages so the fee is slightly higher **\$1500**

❑ **Add-on Screening for Autism Spectrum Disorder with Comprehensive Assessment of the ADOS (any age) \$799: Autism Diagnostic Observation Schedule 2nd edition.** This adds approximately an hour to the comprehensive speech-language assessment. It includes the administration of the ADOS, which will be included in the final report and review.

❑ **Add-on Screening for Autism Spectrum Disorder with previous comprehensive Assessment of the ADOS (any age) \$1500** If you already have a comprehensive speech-language assessment from another practice within the past 6 months, this can be done as a separate service. A "screening" provides information about the likelihood of an autism diagnosis, but would need to be confirmed by a physician, psychologist or multi-disciplinary team. We will also review home videos, conduct play observations, consult with the child's preschool/school professionals, provide a written report, which will be reviewed with the parent(s).

❑ **Age 3 to 4 years 11 months: Comprehensive Speech-Language Assessment: \$1800.** This includes everything: language development, pronunciation, engagement and attention span, oral-motor exam, social/play and getting input from any daycare/preschool teachers. If the child is not yet talking and a possible candidate, we can also trial an assistive augmentative communication (AAC) device; if at least 4.5 years old and has multiple speech errors, we may also administer phonological awareness tests.

❑ **Age 5 years to 6 years 11 months: Comprehensive Speech-Language Assessment \$2200** This includes everything: language comprehension and expressive language development, attention span, pronunciation, oral-motor exam, social/play, auditory memory, getting input from any daycare/teachers or school-based SLPs if desired, and if the child is not yet talking and a possible candidate, we can also trial an assistive augmentative communication (AAC) device. If the child has multiple speech errors we may also administer phonological awareness tests and possibly a hearing screening.

❑ **Ages 7 and up: Comprehensive Speech-Language Assessment \$2500** This includes everything: language comprehension of questions and stories, following directions, expressive language development, pronunciation, oral-motor exam, social/play, getting input from teachers, psychologists, OTs and/or school-based SLPs if desired. If we feel there may be possible word retrieval or auditory memory or processing issues, we will add those tests and possibly a hearing screening. If the child is not yet talking and a possible candidate, we can also trial an assistive augmentative communication (AAC) device. If the child has multiple speech errors we may also administer phonological awareness tests.

❑ **Bilingual Assessment for Toddlers/Preschoolers up to age 3 years 11 months (Mandarin/English**

or Cantonese/English) **\$2300** This includes everything: language comprehension and expressive language development in both languages, pronunciation analysis in both languages, engagement and attention span, oral-motor exam, social/play and getting input from any daycare/preschool teachers. If the child is not yet talking and a possible candidate, we can also trial an assistive augmentative communication (AAC) device.

☐ **Supplementary Testing:** is for children who have previous speech-language, neuropsychological or similar reports/assessments within the past 9 months and whose parents would like additional information, such as aspects of auditory processing, a more-in depth expressive language component to what was already done or an AAC assessment and/or trial an AAC app with support and input from our staff. Fees are prorated by time spent at twice our therapy rate for a 45 minute session (\$170x 2=\$340) plus \$340 for the report, total \$680. For two 45-minute sessions, would be \$1020. For three 45-minute sessions, would be \$1360. If the testing requires additional time, we bill at the full assessment rates as above.

THERAPY

If you have previously previous assessment reports:

New clients with previous assessments should expect that initially, at least 1 or 2 sessions will be spent on our staff obtaining updated/supplemental testing in order to develop appropriate treatment goals and to establish baselines for the skills we will be working on with your child. This provides us with necessary data with which we can measure future progress and also helps our staff pinpoint gaps in learning/skills and zero in on what your child needs. Assessment sessions are billed at twice the usual therapy fee for the time spent. You will be provided with the testing results and updated goals. *New clients with no prior assessment reports will need to start with a formal assessment.*

HANEN PROGRAM FOR PARENTS (More Than Words®)

We offer a Hanen group parent coaching via Zoom classes, once a year conducted by Kristen White, our Director of Clinical Services. In 2025, this program will be conducted on an individual basis rather than in a group setting. The More Than Words program is for parents who have children diagnosed with autism or other social communication difficulties. This program is for parents of children ages 18 months to 5 years old. The initial pre-program consultation with Kristen would be billed at our hourly rate (\$226). This program provides concrete strategies to help you help your child learn to develop social communication skills which leads to increased communication overall. Personalized individual hour sessions will then be held for \$310 via Zoom and your child should be present for all sessions.
