1. Photocopy of the terminated license that has been signed and dated by the managing broker. Keep a copy of the terminated license for your records.
2. Return the license to the licensee.

If you are unable to provide a copy of the terminated license, please submit a written request to terminate the license including the following information:

1. Name and license number of the sponsoring firm.
2. Name and license number of the licensee being terminated; and
3. Date of termination
4. Provide licensee with a copy of the letter and maintain one for your records.

If the managing broker of the office/firm has changed, please submit the following to the Department of Financial and Professional Regulation:
