Regular Meeting
October 13, 2025
7:00 p.m.

Henry McNutt, Don Reed, Tyler Kovach, Aaron Raible, myself and 10 signed in guests were in attendance.

No audio or video recorded meeting.

Open to the Public: There were no comments.

Old Business:

The minutes from the September meeting were read. Don made a motion to approve the minutes. Tyler seconded. Carried.

Reminded residents Halloween Trick or Treat is Friday, October 31 from 6pm-7pm.

A lengthy discussion on hiring part time Saxonburg Borough police at \$56/hr for one day a week totaling approximately \$30,000/yr to help enforce ordinances, over weight trucks, ATVs, and other violations. Residents expressed their dissatisfaction, as we are a rural farming area and any traffic violations would most likely be our resident. Overweight trucks would need DOT scale and state would get half the money. They are more comfortable with state police, one township officer may not be able to handle any major incident. The cost of this when our economy, costs, and taxes are raised. Discussed Code Enforcement officer. Don mentioned that Oakland Township is not happy with them. Henry said this the meeting with the Saxonburg Police was an informational only and wouldn't be voted on this year and he wouldn't be here. No action was taken.

New Business:

The treasurer's report was read. On 10/08/2025, General Fund \$56,506.58 (adj \$44.14). Deposits \$563,682.95 (inc DCED grants \$421,912, Money Market transfers of \$36,996.30, \$72,000). Disbursed \$563,682.95. Ending \$38,695.00. State Fund \$144,601.06. Deposits \$5.94. Disbursed \$8,353.94. Ending \$136,253.06. Sewage Fund \$12,495.84. Deposits \$.52. Disbursed \$.00. Ending \$12,496.36. Capital Reserve Fund \$398,334.19. Deposits \$32.74. Disbursed \$.00. Ending \$398,366.93. Equipment Fund \$48,043.37. Deposits \$2,502.05. Disbursed \$.00. Ending \$50,545.42. Building Fund \$62,792.18. Deposits \$1,002.62. Disbursed \$.00. Ending \$63,794.80. Traffic Light Fund \$37,044.33. Deposits \$.91. Disbursed \$.00. Ending \$37,054.24.

Don made a motion to approve the treasurer's report. Tyler seconded. Carried.

Don made a motion to approve transferring from General Fund-\$2,500 to Equipment Fund, \$1,000 to Building Fund, and \$500 to Money Market. Tyler seconded. Carried.

Don made a motion to approve the Foreign Fire distribution calculating the percentage of calls. Tyler seconded. Carried.

Tyler made a motion to adopt Resolution #25-10-01, America 250 as requested by Butler County, celebrating the 250th birthday of America. Don seconded. Carried.

Don made a motion to approve eligible supervisors to attend PSATS Boot Camp at \$239 per person. Tyler seconded. Carried.

Diane Morrow, our E/I tax voting delegate and is asking if we are happy with Berkheimer as our E/I Tax Collector or would we like them to get quotes from others. Some townships are not happy. Although, we do not have complaints, Tyler made a motion to seek quotes to see what others offer. Don seconded. Carried.

The building is completed thanks to Blair Construction and DCED LSA grant. The building locks have all been rekeyed and cylinders replaced as needed.

Supervisors approved to change the duplicate address of 398 Moran Road with 911 and Butler County Mapping.

Supervisors agreed to submitting LSA grants for road projects from one application to breaking them up to high priorities for more DCED consideration.

Henry made a motion to place legal ad for sealed bids for 1,500 T ashes and 1,500 T antiskid to be opened at next month's meeting. Tyler seconded. Carried.

Henry reminded residents of the replacing mailboxes. Township is only responsible for mailboxes physically damaged by our truck. Mailboxes damage by snow buildup by plowing is not our responsibility.

Planning Commission: No business

Building and Sewage Permits:

Supervisors agreed to send a letter to George Floyd at 402 McGrady Hollow Road to follow up a complaint of a pavilion built too close to property line.

With no further business, Don made a motion to adjourn the meeting. Tyler seconded. Carried.
