Applying for DCED grants was discussed. Tyler will contact Elan Lewis Welter and ask if she can help. She has written grants for others.

We are in need of another summer help employee. A 15 year old boy may be interested. We will review Labor Laws and supervisors agreed to hire if conformed.

Carbon Center Road has a mine subsidence hole in the area of 714 Carbon Center Road. We have a map of mines in that area. Jake filled with Rip Rap and DEP was contacted. DEP will cover the cost of stone to fill. We will get quotes for seismograph testing to see the extent of work needed. We will get quote from Bauer Excavating for cost of road opening. We will contact Marci Mustello for any help.

The complaint of Rays Road, a private road, and Shields Paving using it was when sealing Cornetti Road was followed up. Tyler spoke with Shields Paving and did not tell them to 'not to pave it' diffusing rumor it was said. Don asked Jane if she talked with Shields-she did not. Shields Paving took before and after pictures of road. They used the front part for a piece of equipment. John Sanders saw 3 triaxles on it. Don said he inspected road. This is a civil matter between Rays Road residents and Shields.
