I hereby certify that the local law annexed hereto, designated as local law No. of 19 of the County of Belmont was duly passed by the Town Board (Name of Legislative Body) on 19 and was approved by the Elective Chief Executive Officer repassed after disapproval on 19. Such local law being subject to a permissive referendum and no valid petition requesting such referendum having been filed, said local law was deemed duly adopted on 19, in accordance with the applicable provisions of law.


