

Rules and Expectations

The 2022 photo contest theme is "Agriculture in the Southwest". The contest will be open September 9th – October 3rd.

WINNERS

Grand Prize: The winning photo will receive a \$150 assorted Beef Box from Five Heart Farms.

2nd Place: \$100 Assorted Beef Box from Five Heart Farms.

3rd Place: \$50 Leals gift card.

4th Place: \$25 HTeaO gift card.

Winning entries will be announced October 7th, 2022.

Judges will be appointed by Agri-Plan management. The decision of these judges will be final, and the judges will not be eligible to win this contest.

ELIGIBILITY

The contest is open to all individuals who complete and return the entry form. All contestants must abide by the terms and agreements of these official rules. In order to be considered for the photo contest, images must be taken within the continental United States. Entries will not be considered without a completed entry form.

ENTRIES:

Submitting photos for the contest is free. Photo entries must be a high-quality digital image with a **minimum of 300 DPI in landscape format**.

Digital photos should be taken at the highest resolution possible. Please try to use a device with 8 MP (megapixels) or higher. Failure to submit a high enough quality image may result in disqualification.

DEADLINE FOR SUBMITTING ENTRIES:

All photos and accompanying entry forms must be received by **October 3rd, 2022** for consideration.

PROPERTY RIGHTS:
