

Rules and Expectations

Winning entries will be announced October 7th, 2022.

Judges will be appointed by Agri-Plan management. The decision of these judges will be final, and the judges will not be eligible to win this contest.

ELIGIBILITY

The contest is open to all individuals who complete and return the entry form. All contestants must abide by the terms and agreements of these official rules. In order to be considered for the photo contest, images must be takes within the continental United States. Entries will not be considered without a completed entry form.

ENTRIES:

Submitting photos for the contest is free. Photo entries must be a high-quality digital image with a minimum of 300 DPI in landscape format. Digital photos should be taken at the highest resolution possible. Please try to use a devise with 8 MP (megapixels) or higher. Failure to submit a high enough quality image may result in disqualification.
