RPI APPLICATION INSTRUCTIONS

1. Fill out application completely (*please print clearly or type*).
2. Submit three typewritten letters of recommendation from other ministers familiar with your ministry. If you have a pastor, one should be from them. Each letter must include contact information of the referring party.
3. Submit typewritten doctrinal statement including Scriptural references.
4. Submit typewritten personal testimony (*no more than two pages in length*).
5. If you have a partner or spouse, submit a letter of endorsement from them.
6. Submit **copies** of all ministerial degrees, diplomas, certificates, licenses and ordinations.
7. Make a check/money order to RPI in the amount of \$50.00. If you would like to pay online, please visit www.rpifellowship.com and go to the giving section. This is a non-refundable application fee. If approved, the fee will be applied to your first annual dues.
8. Deadline for submission is 45 days before annual RPI Conference.
