## Morgan College of Ministries



Originally named RPI Bible College, Morgan College of Ministries was renamed in 2023 as a way to honor the life and ministry of Reverend Mother Gloria Sue Morgan (January 12, 1939– September 17, 2023)– an influential prayer warrior, worship warrior, teacher, preacher, minister of the gospel and spiritual mother to many in our organization. She dedicated her life to the Lord at a very young age and continued in ministry within the LGBTQ+ community after a personal experience brought her to fully understand that Whosoever as it states in John 3:16 does not leave anyone out regardless of their sexuality or gender identity. Mother Morgan, or “Mama” as many called her, became a spiritual mother to many generations of our community who otherwise lost their connection and access to family.

Education is an element of ministry that Mother Morgan was passionate about, especially as she mentored new ministers. It is with this in mind that the RPI Board of Presbyters sought to establish a lasting monument in her name by renaming RPI Bible College to Morgan College of Ministries in her honor in September 2023.

Mama left a legacy of Love, acceptance, perseverance, excellence, and determination, prayer and worship of Jesus Christ; those of us who had the honor of knowing and interacting with her have been forever changed because of her ministry. Morgan College of Ministries stands to see that legacy continued through offering an educational program she would have been proud of that mentors and equips powerful witnesses of the gospel of Jesus Christ.

## **STATEMENT OF FAITH**

Morgan College of Ministries is an educational outreach of Reconciling Pentecostals International; a Christian organization of several churches, ministers and ministries, both nationally and internationally. As an outreach ministry of RPI, Morgan College of Ministries adheres to RPI's Statement of Faith.

### **We believe in...**

**One True God** who manifested Himself as the Father in creation, Son in redemption, and the Holy Ghost in regeneration. The Father is the fullness of God invisible. The Son is the embodiment of God's fullness in flesh. The Holy Ghost is the fullness of God in the church by emanation. Deut. 6:4; Isaiah 43:10-11; Hosea 13:4; Mark 12:29 & 32; I Cor. 8:4-6; I Tim. 2:5; James 2:19.

**Christ's Absolute Deity** as the One True, Almighty God manifest in the flesh. Jesus Christ was fully human and fully divine. We believe in His virgin birth, sinless life, miraculous ministry, substitutionary death and bodily resurrection. II Cor. 5:18; Isaiah 7:14; Matt. 1:23; Heb. 4:15; Acts 10:38; II Cor. 5:21; Acts 2:31-32; John 1:1 & 14; John 10:30; Colossians 1:9; 2:9; Col. 1:19; II Cor. 4:6; I Tim. 4:10; Titus 2:13; Jude 25.

**The Bible** is utterly trustworthy and reliable as the final authority for faith and practice. It is the divinely inspired, infallible Word of God and as such must be understood and interpreted correctly, maintaining its original historical and cultural context. We make no contention for a perfect translation but believe that the Bible as we know it today is trustworthy and reliable as the final authority for faith and practice. II Timothy 3:16; Matthew 24:35.

**A Sinful Nature** has been inherited by every person who has also sinned of their own volition, making them sinners in need of a Savior. Psalm 51:5; Romans 3:23.

**The Salvation experience** is received by grace, through faith in the shed blood of the Lord Jesus Christ. Salvation is initiated by God and calls for our surrender and acceptance. It is available to all who receive it. God's grace is appropriated through faith, which we demonstrate by obeying the New Testament plan of salvation as preached by the early church. Today, as then, a person is saved (born again) by faith in the Lord Jesus Christ, which is evidenced by obediently identifying with His death, burial and resurrection, accomplished by the Blood of Jesus through:

- The death of our "old man" in repentance.
- The burial of our sinful nature in baptism by total immersion in water, into the Name of the Lord Jesus Christ. This act is the New Testament circumcision of the heart that is a sign of God's covenant with those who are called by His Name.
- Our resurrection to newness of life through the infilling/baptism of the Holy Ghost with the initial evidence of speaking with other tongues. This birth of the Spirit is for us today and was the expected experience of every New Testament believer.
- These serve as conduits of our faith toward God and His grace toward us.
- References include: John 3:3-5; Mark 16:16 & 17; Acts 2:4,38-39; Acts 8:16; Acts 10:46-48; Acts 19: 5-6; Acts 22:16; I Cor. 14:5,18; Romans 8:9,11,15 & 16, I John 5:8; I Corinthians 15:1-4; Hebrews 9:22; Romans 6:4-6; Titus 3:5.

**Holiness** unto the Lord and separation from evil and all addictions of the flesh is essential and should characterize everyone who has been spiritually regenerated. We are to flee worldliness



and carnality in pursuit of the righteousness of God in our lives. I Peter 1:15-16; I Thess. 5:22; II Cor. 6:17; I John 2:15.

**Our Mission** is to make disciples, relieve suffering and minister to those in need. Matt. 28:19; Mark 16:15; Luke 24:47; Acts 1:8; Matt. 25:35-46; James 1:27; I Cor. 11:23-30.

**Healing and Deliverance** has been provided by God in the atonement and can be manifested in response to the prayer of faith. Luke 10:9; Mark 16:18; James 5:14-16; I Peter 2:24.

**Jesus Christ's Impending Return** for His church will happen at the appointed time, and someday all will stand before Him to receive eternal reward or face eternal punishment. There will be a literal seven-year tribulation during which time the anti-Christ will be revealed. Following the Tribulation, the Battle of Armageddon will be fought and will culminate in Christ's victory and His one-thousand-year reign of peace. There will be a final judgment where the souls of men and women will be assigned eternal reward or punishment in a literal Heaven or Hell. Matt. 24; I Cor. 15:15, 52; I Thess. 4:13-17; Rev. 7:14; Rev. 16:16; I John 2:18; II Thess. 2:3-4; Revelation 7 & 19:1-22.

**Intimate Relations, Marriage and Divorce:** Since we have been baptized into Christ and have put on Christ according to Galatians 3:27-28, there is no longer a distinction between Jew and Greek, bond and free, male and female since we are all one in Christ. And whereas God is no respecter of persons (Acts 10:34), we believe same-sex relationships are held to exactly the same Biblical standard as heterosexual relationships in the sight of God. Marriage is a sacred, lifelong covenant between two people and their God, in which sexual fidelity is maintained. We call upon human governments to recognize the equality and dignity of same-sex unions, providing all the same benefits afforded their heterosexual counterparts. Until such time as this equality is realized, we encourage those entering into same-sex unions to acknowledge their sacred marriage vows before God in a specific ceremony witnessed by others.

- With regards to sexual conduct, we strongly admonish our ministers and members to conduct themselves according to the Bible standard of intimate relations. We acknowledge one standard for all individuals, regardless of sexual orientation. We believe the only acceptable form of sexual expression between two people is that which takes place within the context of total commitment and marriage. Hebrews 13:4

### **Leading Principles**

Morgan College of ministries is equipped to train, guide and mentor its students by providing students with opportunities to develop their understanding of scripture and ministry. Scripture is the foundation of the purpose of Morgan College and will be used in every course.

“And the things that thou hast heard of me among many witnesses; the same commit thou to faithful men, who shall be able to teach others also.” (II Timothy 2:2, KJV).

“Study to shew thyself approved unto God, a workman that needeth not to be ashamed, rightly dividing the word of truth.” (II Timothy 2:15, KJV)

### **Method of Evaluation**

Students knowledge of coursework and ministry are evaluated at the end of each quarter with a 5 page written essay covering a provided prompt. Students will also be evaluated in public speaking through Preaching and Teaching Practicums held for students in levels 2-4 of learning.

Google Classroom will be utilized for assignments, communication and live lecture courses.

### **Learning Objectives/Outcomes:**

1. Students of Morgan College of Ministries will develop basic skills of examination, understanding, and application, in their study of the Bible.
2. Students will identify and explain the significance of themes, events, historical importance, cultural meaning, and personalities found in the Old and New Testaments.
3. Students will identify and describe pertinent background, interpretive questions and relevant information pertaining to books found in the Old and New Testaments.
4. Students will have an understanding of End Time Prophecy found in the book of Revelation.
5. Students will appropriately apply knowledge to life and service the biblical teachings and principles learned in their course of study.
6. Students will develop the ability to adapt their studies to practical application.
7. Students will acquire necessary ministerial, biblical, counseling and ethical skills to advance in church leadership.
8. Students will develop critical evaluative skills in interpreting Christian literature as well as an ability to communicate these skills to others.
9. Students will become proficient in public speaking whether through preaching and/or teaching.
10. Students will learn to balance and persevere through various aspects of life and ministry.

### **Personal Spiritual Development Objectives:**

1. To develop a personal/spiritual appreciation for the Christian/apostolic heritage.
2. To develop and instill a biblical understanding of reconciliation in the LGBTQ+ community.
3. To instill a desire for lifelong commitment to personal spiritual growth through daily Bible study and prayer.
4. To develop attitudes of service and commitment to the local church.
5. To equip individuals with a Christian worldview that enables them to manifest a biblically separated lifestyle.
6. To foster Christian culture, developing refinement, appreciation, social attitudes, and skills.

## Course Descriptions

When a student has completed each level of study, they will receive the correlating certificate. After completion of Level II Courses, the student may be eligible, if they choose, to apply for an Associate's License with RPI although this is not a requirement to remain in Morgan College as a student. For those seeking or currently licensed with RPI, ministers are required to hold their license for two (2) years before being eligible to apply for the next level of licensure. With this in mind, students will become eligible to apply for an Associate License with RPI upon completing Level 2 Coursework and a General License in RPI once they have completed Level 4 and graduated from Morgan College of Ministries. Students will need to hold their General License for ministry in good standing for two (2) years before applying for Ordination.

- Level I Courses – Learning basic foundational principles of Christian living, personal growth, reconciliation, church doctrine and biblical history.
- Level II Courses – Expands on level one learning providing students with a deeper understanding of theology, Biblical studies, preparing for teaching and preaching ministry as well as an introduction to leadership and conflict management.
  - Students may apply for an Associate's License with RPI upon completion of this level.
- Level III Courses – Students broaden their knowledge in doctrine and theology, Biblical understanding, preaching and teaching ministry and discipleship.
- *Level IV Courses* – Study at this level prepares the minister for higher levels of leadership within the organization, an understanding of eschatology and pneumatology, evangelism, missions and advanced preaching and teaching courses to fully prepare the student minister for ministry upon graduation from the program. Students will also have an opportunity to present a Senior Capstone at the end of the fourth quarter.
  - Associate Licensed Ministers may apply for General Licensure as a graduate of Morgan College of Ministries.

Please note, that the Morgan College of Ministries offers Certificates of Completion for each completed level of study, which are separate from licensure by the RPI Board of Presbyters. *Licensure in ministry is managed by the RPI Board of Presbyters not through Morgan College of Ministries.*

## **Categories in RPI Course Studies**

Students are expected to complete course objectives from the following categories of study:

**REC Reconciliation**- Students will be proficient in the area of reconciliation to Jesus Christ regardless of gender, gender identity, sexual orientation, ethnicity, financial status or any other criteria used to limit access to salvation in Jesus Christ.

**OTH Old Testament History**- Students will acquire a high level understanding of Old Testament historical accounts and how these events point us to the fulfillment of the Messianic prophecy in Jesus Christ.

**CHS Church History**- Students who complete all levels of Church History will gain proficient knowledge in historical accounts of the foundation of the church leading up to current events in the church.

**CLS Church Leadership Studies**: Upon completion, students will operate in efficient and healthy church leadership.

**THE Theology**- Students gain knowledge of various areas of theology from basic areas of doctrine to understanding specific Pentecostal theology.

**NTS New Testament Studies**- Covers areas of the entire New Testament from the Gospels and epistles to eschatology and Pneumatology.

**DEM Discipleship Evangelism and Missions**: Students will have an understanding of becoming and making disciples of Jesus, evangelizing their community and missions on the ministry field.

**PTP Preaching and Teaching Practicum**: Courses will cover mechanics of preaching and teaching and provide students with an opportunity to implement elements of learning in live online practicums

**SC Senior Capstone**- Senior students will submit a final assignment that encapsulates their time in Morgan College of Ministries. For this project, students will shadow a local minister and/or interview an RPI minister and prepare a presentation regarding their experience. Shadowing and interviewing will consist of asking questions regarding the minister's routine for service and sermon/lesson preparation, what their personal routine consists of, observing leadership style, and any other activity that benefits the student in their ministry. In the presentation students will also share how the experience has impacted their personal ministry and what their goals are as a graduate of Morgan College of Ministries.

**Application Requirements:**

Morgan College of Ministries goal is to assist all individuals who are Spirit-filled, living a holy life and are in the process of answering the call to ministry in different capacities within their church, ministry, community, mission, etc. Students who are interested in applying for this program may apply via the application attached at the end of this catalog. We encourage all prospective students to seek out the support of their local Pastor before applying.

The candidate must be in good standing in their own local church and be living an exemplary life. The candidate accepted into this program will be expected to complete their course of study according to the term schedule outlined in this application and in the online classroom. Morgan College of Ministries utilizes Google Classroom as the

chosen platform for submitting essays, grading and communication between educators and students.

**Qualifications:**

- Be baptized in water by full immersion
- Possess an affirmation of a call to ministry, or desire to grow in Christian experience
- Have their pastor's approval to enter the program
- Complete an application with supporting documents
- Be accepted by the Educational Committee
- Pay a non-refundable processing fee for application and course evaluation

**Fees**

Students entering Level I are required to complete and submit the application for the Morgan College of Ministries, along with a non refundable application fee of \$50 to RPI Headquarters. Upon acceptance, students will begin their coursework when the term begins. All students who do not wish to seek licensure with RPI are only required to complete Level I. Students who wish to seek licensure must complete levels I-IV and will be required to take Continuing Education Units (CEU) biannually in order to remain in good standing with RPI.

The application fee will go towards the first course of the term with each course requiring a \$50 fee totaling \$200 per year of coursework for Levels I-IV and \$50 per CEU.

**Life Experience and Transfer Credits**

What is Life Experience Credit or Credit for Life Experience?

Life Experience Credit has been loosely defined by some as; "The philosophy that Academic Credit is given for what you know, without regard to how, when or where the learning was acquired."

Morgan College of Ministries Students who are enrolled may apply for Life Experience Credit (LEC). LEC may be earned for verifiable experience in your given area of study. Credit may be earned for learning experiences as outlined in this category of learning. Students may earn up to three credit hours for every documented category of experience. The amount of credits granted for LEC is subject to evaluation.

Transfer credits from another recognized institution will be evaluated on a case by case basis to determine how many credits will transfer to the program. Transfer students may or may not enter into Morgan College at the same level as their previous program (ie: KingdomGate College of Ministries students may or may not enter into Morgan College at the same level as they were in KCM). The total amount of transfer credits are subject to approval of the college education committee.

Transfer students are required to submit transcripts with their initial application. Those seeking LECs are required to submit documentation of the experience which is subject to the education committee's discretion for approval. Submission of either transcripts or LEC documentation is not a guarantee of credits.

### **Applying for Life Experience Credit**

A separate LEC application should be submitted with the Student's initial application. There may be supplemental documentation requested after you submit the LEC application. Once all requested documentation has been obtained, the Education Committee will inform the student of their findings within 30 days from receipt of application and documentation and determine the amount of coursework and credits that will be allotted to the student. The Educational Committee of Morgan College reserves the right to reject any request for LEC not properly documented, and to the limit of credit applied from all documented Life Experience.

### **Accepted Life Experience Work (All work must be documented)**

- Trainings (as the trainer or learner)
- Teacher (Sunday School, Bible Study, Seminars, Workshops, etc.)
- Mission Work under leadership of a church or Christian Group
- Ministry (as stated above)
- Written/Published Work (Books, Articles, etc.)
- Other (as approved by the RPI Educational Committee)

### **Cost**

There will be an extra \$75 application fee for Life Experience credit to cover the review, evaluation and processing of documentation. This fee is based on the amount of material

submitted for review, as determined by the Educational Committee, in cooperation with the RPI Board of Presbyters. Students who are initially applying to Morgan College who wish to use LEC in their application would therefore pay a total of \$125 for their application fee with \$50 going toward their first course upon acceptance into the program.

Students who do not uphold the standard of excellence in their public or private life are at risk of behavioral probation or dismissal if the behavior persists. Given the structure of the college, students are allowed a total of 3 instances of disciplinary action per academic year regardless of what combination of discipline the student receives. Students who receive more than 3 will be automatically dismissed from the program and will need to reapply the next academic year.
