- 6. Submit copies of all ministerial degrees, diplomas, certificates, licenses and ordinations.
- 7. Make a check/money order to RPI in the amount of \$50.00. This is a non-refundable application fee. The fee will be applied to your first annual dues.
- 8. Deadlines to be scheduled for the two annual credentialing reviews are: January 5 for General Conference or July 15 for MSQ.
