

MILITIA FRONTEND STRUCTURE

- National Militia Coordinator (Director) Will Ensure Continuity Of Structure & Training For The Militia Throughout Each State. Will Act As Liaison Between The Militia (We The People) And The Federal Government. Will, On Behalf Of The Militia & We The People, Inform, And Put On NOTICE Via Militia Law Office, The Federal Government When It Is In Breach Of Its Duties, Responsibilities & Lawful Obligations.
- State Coordinators Will Ensure Continuity Of Structure & Training For Militia Throughout Each County In Their State. Will Organize & Coordinate Training (See details on website) For Their County Militia Groups. Will Ensure Their State Has A Constitutional Governor And Will Work In Friendly Cooperation With Such A Governor.
- County Coordinators Will Recruit, Organize, And Train Men & Women Within Their County Who Choose To Join And Participate In The Militia. Will Connect Qualified Recruits With Appropriate Personnel Within The Militia Combat Structure (Outlined below). Will Ensure They Have, And Will Work In Friendly Cooperation With, A Constitutional Sheriff.

MILITIA BACKEND (COMBAT) STRUCTURE

State Commander

- Executive Officer (2nd in Command)
 - o Regiments (Commanders)
 - Battalions (Counties)
 - Companies (Cities / 100 men)
 - \circ Squads (8-12 Men)
 - Fire Teams (4 Men)

NOTE: The primary purpose of the backend (combat structure) of the Militia is to train and prepare for Foreign Enemy Invasion of the USA.
