OFFICIAL NOTICE of OPPOSITION to Hawaii islands being a Sanctuary State or City

Re : The past introductions of certain Bills, like Bill 31 for Ordinance by Honolulu County Council, are examples of law makers not having the public's best interest at the forefront.

NOTICE OF OPPOSITION : A FORMAL and OFFICIAL NOTICE of OPPOSITION by The Justice Council to any Sanctuary Bills by The State of Hawaii or any of its' Counties Now and in the Future

(This NOTICE of OPPOSITION to Sanctuary City laws is hereafter known as NOTICE. This letter is official NOTICE that we will do hereby oppose now, and any future attempts to propose any and all Sanctuary City laws within the State of Hawaii, or any City and County in the State of Hawaii.)

Topic : **Sanctuary Cities Undermine Law Enforcement and Endanger Our Communities**

Consequences of Sanctuary Cities include, but are not limited to :

- 1.) Violation(s) of the Constitution and Federal Laws with premeditated acts to obstruct law enforcement, endanger the lives of U.S. Citizens and more
- 2.) Create a larger homeless problem
- 3.) Increased crime and physical harm, like murder, rape, and other issues, by these illegal migrants
- 4.) Outbreaks of deadly diseases
- 5.) Terrorists attacks
- 6.) Economic ruin
- 7.) Loss of culture (American, Native American and Hawaiian)
- 8.) Infliction of mental anguish/harm upon U.S. Citizens from stress due to affects of illegal immigration
- 9.) Many various other types of problems increase with larger numbers of illegal immigrants encouraged by Sanctuary laws
- 10.) Violations of public safety, public welfare and public trust, etc...

Sanctuary Laws are ABSURD !!! And Destabilize this Country !!!

In conclusion, the State of Hawaii or any of its' Counties cannot become a Sanctuary State or City. Hawaii : does not have enough ICE Federal agents that could handle these masses, does not have the infrastructure medically to handle disease out breaks, does not have funding for them to utilize services meant for tax paying citizens because ultimately that would happen, economic ruin is certain especially with hordes of beggars in the street begging tourists, terrorists can slip in with these mass migrations as well, will see a dramatic increase in crime by foreigners (which ends up being a police matter anyway when citizens call to report things rape, then the local police cannot arrest them), will end up looking for where to send these illegal migrants next after we have migrant camps on top of our already large homeless problem, from other Sanctuary Cities sending us their problems.

So, all a Sanctuary Country, State, City or County does, is to serve illegal immigrants and not U.S. Citizens (It gives illegal migrants special privileges that our Citizens do not have. Citizens are not shielded from arrest by local police. Plus, it is cheaper for the tax payer to pay the police to arrest them, than to pay to have all the problems mentioned in this NOTICE.

In fact Sanctuary Cities laws opposes the very purpose of States and Cities mission to protect, serve, and represent us, the U.S. Citizens.

Yes, States and County governments have a right to autonomous local government under the Constitution's Tenth Amendment, however : they cannot violate the Constitution, cannot avoid Federal law, and/or cannot recklessly endanger Citizens' lives. Also, violations of State Ethics and Public Corruption Laws do specify jail time for acts that qualify. Public corruption qualifies under this issue, which includes border corruption; one of the parameters of Sanctuary City laws. They violate border issues, and when done deliberately can be a criminal issue. <https://www.fbi.gov/investigate/public-corruption>

Plus, current government Hawaii State and County officials have to know about the issues involved with Sanctuary Cities, and the European request for a "quota system" to distribute these illegal immigrants world wide; and the results of taking them in can do. This information in this NOTICE is easy to find on the internet.

If governmental officials want to claim they did not, or do not, have knowledge of the detrimental affects of Sanctuary City laws as mentioned in this NOTICE, then they should resign or be removed from Office for not being educated about what has already happened around the world before proposing such a dangerous Bill. The information of the harmful affects of Sanctuary City law issues are easily accessed on the internet. The issue has made the news. So, how can they claim they did not know these facts prior to submitting Bill 31 ? Since the Bill was proposed, it probably would mean there are many other Bill proposals that were not properly investigated prior to their introduction to become a Bill; which were either passed as laws, or died as Bills. This is beyond unethical, reckless, irresponsible, violates public trust, undermines the operations of our government and it's mission to represent and protect the people, could be seen as a violation public corruption, violates Citizens rights, etc...and is possibly criminal.

The State of Hawaii has often tried to act like it does not need to comply with the Federal government and the Constitution. For, example, why did it take so long for Hawaii to remove my social security number from being used as my driver's license number? That issue actually reflects negligence on the part of the State of Hawaii. I, Thunderfoot, probably still have an old one with my social security number as my identification number on it laying around. Having your social security number on a driver's license was found to be UnConstitutional and that is why the State of Hawaii removed our social security numbers as our driver's

license identification number to a number system it created to replace the use of social security numbers.

It is negligent and irresponsible for governmental officials to not keep up with Federal requirements ! In the same vein, it is irresponsible for a Sanctuary City law to be passed, or even introduced. It violates Federal immigration laws and endangers communities.

The tax payer would save a lot of money if the State and Counties of Hawaii would hire an independent Constitutional attorney to advise them, since the State and Hawaii Counties have already passed laws that violate the United States Constitution, and have ignored the Constitution and Federal laws as well. The Constitution and the Federal government allows local State and County governments to exist as governmental units under their umbrella. So, Citizens need to have their Constitutional rights protected over Corporate rights (the State and Counties); which currently happens frequently. The very submission of Bill 31 by the Honolulu County Council is a glaring example.

Preservation of the Citizens' rights under the Constitution and Federal laws should be the priority. If aforesaid protection of Citizens' rights are ignored and/or violated, it is an act in and of itself of violating the Constitution and Federal laws.

Why do Citizens have to participate in government to get the government, that is supposed to represent them, to comply with this Country's foundations that allow them to exist and function in the first place? The answer is, it should not happen. Issues like this causes the public to lose faith in government which creates a wider divide between the two, that are supposed to work together. It is Citizens' rights to not participate in government if they do not want to. If they choose/chose that option, it does not means the government can ignore their rights due to their lack of participation. In fact a lack of participation by Citizens may be magnified by current UnConstitutional laws, statutes, and/or ordinances, procedures, policies and custom in government that allow for Citizens to give testimony or input in government decisions at public meetings. Because these said Hawaii County public meeting procedures and policies do not allow proper notice of meetings to the public, proper time frame for consideration of written and verbal testimonies, proper time frame to check facts and talk to experts, etc... it essentially denies Citizens' rights to participate in government because their testimonies are not properly and reasonably considered. These UnConstitutional policies and procedures actually deny Citizens rights to participate in government, and actually omit the actual person, not just their testimony since they are one in the same in regards to public testimony of government agenda items.

For example, in Hawaii County Council public meetings, the public testifies to an agenda item prior to the agenda item presentation, that means facts are omitted that may affect the person's testimony. Therefore, their testimony cannot be properly considered since there is an omission of facts by the government, which leads to omission of the Citizen/person themselves since they were not included. This procedure prevents Citizens from having all the facts to testify. The result is the governmental unit denying the Citizens' rights to participate in government. Also, written testimony and verbal testimony need a reasonable amount of time for consideration. For written testimony, it is 3 days. That is not enough time. Plus, a vote on the agenda item people are there to testify to, takes place right afterward verbal testimonies are submitted. There was obviously not enough of a time frame to consider their testimonies. It is a blatant disregard for their input preventing Citizens from their right to participate in government. These issues just described are actual Constitutional violations that can have legal consequences.

Further, by allowing in illegal immigrants, the result of Sanctuary City laws, it could destroy Native American culture, Hawaiian culture ,and American culture itself. It would also violate the laws and public trust to preserve this Country's heritage and cultures. Plus, the beliefs of Islam, the main religion of these illegal immigrants, is incompatible with the laws and principles of the United States.

It would be criminal to agree with any actions by the government to contribute to genocide via sanctuary City related laws.

So, these types of Bill creations, like Bill 31, and other practices mentioned and unmentioned in this NOTICE are violations of legal and human rights. Any government in the United States that:

- 1.) violates and/or ignores the Constitution, Bill of Rights, Declaration of Independence, or
 - 2.) omits facts, or
 - 3.) disregards Citizen input and consideration of that input, etc...
 - 4.) disregards public safety, public welfare and public trust etc...
- is : UnConstitutional, irresponsible, negligent, violating public trust, possibly criminal etc...

These illegal procedures, practices, customs, bills, laws, statutes, and/or ordinances contribute to the loss of confidence by the people in their government. Citizens need checks and balances of their government. Citizens also need all government officials to : be familiar with the Constitution, existing and new Federal laws, represent the people, protect the peoples' rights, keep the people safe, accountability, transparency, etc...

So, to protect Citizens, do not propose any Sanctuary City laws. Say no to bringing in massive numbers of illegal immigrants that these types of laws create. Instead of bringing these refugees into our homes, because our Country is our home, we need to address the issues of why these illegal immigrants are fleeing their Countries in the first place. This makes much more sense. If too many of these broken Countries lose enough of their population, it could plunge these Countries further into despair and ruin than they are already in; and keep them there for many years to come. Their Country's health affects the world since the world is so interconnected in numerous ways. We are all on the same planet basically. Their ruin is on top of the ruining the Countries they are fleeing to. Therefore, inviting them into our home would be not only Federally illegal and plain foolish, but possibly criminal.

Then there is the angle of terrorists infiltrating in with these migrant herds, as previously discussed; which the odds of their entry could be decreased dramatically by addressing why there is mass migration from those Countries. Also, there is the factor that many crimes by illegal immigrants use their culture as an excuse to do harm. So, there are many reasons why the problems in the Countries, that are the origins of the illegal immigrants, should be addressed in those Countries.

So, any Sanctuary City proposed bills and/or laws by the State of Hawaii, or any of its' Counties, would be : violating Federal law, unethical, irresponsible, immoral, and possibly criminal, especially after formally being given the knowledge of said issues in this NOTICE. If the State of Hawaii, the City and County of Honolulu, or any other County in Hawaii attempts to introduce and pass any Sanctuary City Laws, it could be seen as doing so with criminal intent since you now have knowledge of said content in this said NOTICE. So, prior knowledge of imminent risk of harm, imminent threat, and imminent danger, which can lead to irreparable harm is a serious matter. And any actions, omissions or conditions that endanger the life, or seriously jeopardize the physical or mental health, or safety of Citizens and themselves ,etc..., like Sanctuary laws, could become a legal matter of irreparable harm, abuse of public trust and more.

Further, the State of Hawaii and its' Counties could face legal action(s) by the Federal Department of Justice for violating Federal immigration laws, causing a variety of harm(s) to U.S. Citizens. This would especially be applicable since the State of Hawaii and any of its' Counties have now been informed that such legal actions have already taken place against California for three Sanctuary City related laws it passed that violated Federal laws.

So, Stop copying California before we go down the drain like they are. We are Hawaii, we are unique. This fact of unique identity, the Constitution, and Federal Laws must be considered in any proposed Laws, Statutes and/or Ordinances in Hawaii to preserve Citizens inalienable rights (that no man can take away), of Life, Liberty and the Pursuit of Happiness; and to comply with the Constitution and Federal Laws.

So, say no to Sanctuary Laws now and in the future.
