**Per NCAA recruiting rules our College Soccer ID Camps are open to any and all entrants, limited only by age, grade in school, or enrollment cap. Natives Futbol Academy College ID Camp welcomes players from grades 8th to 12th also to include junior college players.

12/14/20 UPDATE:

On November 18th, NCAA announced that the Division 1 recruiting dead period will be extended to April 15, 2021, thus the reason we will only have NCAA D3 & NAIA Coaches attending. No in person contact with D1 coaches is allowed through that date. We had anticipated this as a possibility so already have an alternative plan in place to make sure that all of the campers attending get the identification opportunity they are looking for.

- 1) The event will still take place on December 18th as scheduled, due to the fact that it is being held on the site of a Sovereign Nation.
- 2) College coaches from the West Region will still run the training sessions (NCAA D3, and NAIA)
- 3) We will have a coaching speaker component to discuss the recruitment process and how to navigate through all of the change now and in the future

In addition to running the camp as scheduled, we will also provide a spring camp once the Division 1 coaches are allowed to attend per NCAA rules. We have some targeted dates after the end of the new dead period in mind already, just want to do some more due diligence with college coaches on a date that would work for them. We will circulate our new spring dates in the very near future as we are able to finalize all of the details.

The most important mission of Natives FA and our College ID Camp is the placement of players collegiately. We know that all of these aspiring college athletes have had a difficult time through this pandemic and we want to help them. Even though the D1 dead period recruitment date got pushed back we can still use technology, creativity, and our history of relationships and trust with the college coaches to help these players. We are excited to evolve this event based on the circumstances and showcase their abilities in a way that will spotlight and help them take the next step in the recruitment

Participation in said Camp inherently includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist.

I UNDERSTAND AND VOLUNTARILY ACCEPT AND ASSUME ALL SUCH INHERENT RISKS, both known and unknown, even if ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation.

I willingly agree to comply with the stated and customary terms and conditions for participation in Natives FA Day Camp as regards protection against infectious diseases. If, however, I observe any unusual or significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately.

I agree before I enter the Facilities that I have taken my temperature and it is less than 100.4 degrees Fahrenheit and that I have not tested positive or been in contact with anyone who has tested positive for COVID-19 within two weeks of entering the Facilities. While at the Facilities, I will wear a face covering when practical and will to the best of my ability practice social distancing.

I, and my parent or legal guardian if I am a minor, for and on behalf of myself and my heirs, executors, administrators, successors, and assigns, hereby forever release, acquit, and discharge and AGREE TO INDEMNIFY AND HOLD HARMLESS all RELEASEES, their officers, directors, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the Day Camp from any and all causes of action or actions, suits, losses, liability, damages, claims (including but not limited to, negligence, gross negligence, willful or intentional conduct), personal injury damages, medical or hospital bills, property damages, judgements, levies, and executions which the undersigned or his/her heirs, executors, administrators, successors and assigns may have against said RELEASEES arising out of my participation in the Day Camp programming.

I, and my parent or legal guardian if I am a minor, HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
