

Red Flag Football: Controlled Substance Red Flags Case

The NFL season is right around the corner, yet this is not a play on words diminishing the incredible knowledge and expertise of healthcare professionals in matters involving controlled substances, rather a dive into propelling said folk to think deeper.

THE CASE (From Previous Pain Press Issue 4)

A 45-year-old male patient presents to your pharmacy on a Friday night requesting to fill his prescription for hydrocodone/acetaminophen 10/325 mg (1 tablet four times daily) for chronic knee pain. Notably, he exhibits a mild limp while walking. He lives 20 miles from your pharmacy where he was running errands all day prior to driving to see a show with his Wife tonight. He sees a pain management specialist 120 miles from your pharmacy as he fully trusts his doctor and used to live closer to the office prior to moving to your town two weeks ago to be closer to his aging mother in need of family assistance. He states he has been utilizing the opioid for over two years and claims other medications and treatments, such as NSAIDs and physical therapy, "just don't cut it." He denies any history of substance use beyond an occasional bottle of beer during big games. The PDMP shows consistent, yet early, prescriptions from a single provider over the past 12 months, which he explains as "avoiding running out over weekends or holidays." Patient is polite and cooperative but exhibits consternation in his facial expressions when asked why he hasn't sought care closer to home. He reiterated that "finding the right doctor is more important than convenience", and he literally just moved. Additionally, the patient stated that he is readily willing to pay out-of-pocket (credit card for an intentional paper trail) if his insurance provider will not authorize the early fill.

What "Controlled Substance Flags" are involved in this case?

Let's review the 2023 National Opioid Settlement Controlled Substance

Red Flags in general and observed within this case.

National Opioid Settlement Controlled Substance Red Flags

RED FLAGS (PATIENT)

- CS-2 Refill Too Soon by > 3 Days
- Doctor Shopping (CS > 4 Previous Prescribers of Separate Practices over 6 months)
- Prescriber has > 10 documented CS refusals within 6 months
- Previous 3 other CS from multiple prescribers with overlapping days within 30 days
- Distance between patient's residence and pharmacy > 50 miles
- Distance between patient's residence and prescriber > 100 miles
- Previous 2 CS refusals within 30 days
- Cash pay despite having prescription insurance coverage
- >/= 3 Patients appear together for the same CS
- Slang Term Medication Request (e.g., "Mallinckrodt blues," "M's", or "the blue pill")
- Patient appears visibly altered, intoxicated, or incoherent

RED FLAGS (PRESCRIPTION)

- Fails to meet law requirements
- Misspellings
- Atypical Abbreviations
- Multiple Colors of Ink or Multiple Handwritings

RED FLAGS (PRESCRIBER)

- CS-2 + Benzodiazepine + Carisoprodol
- Prescriber has no office within 50 miles of pharmacy
- Prescriber utilizes preprinted or stamped prescription pads

Red Flags Observed in This Case

- Distance between patient's residence and prescriber > 100 miles
- CS-2 Refill Too Soon by > 3 Days (If actually > 3 days in this case)
- Cash pay despite having prescription insurance coverage

Yet, once identified, mitigated, and documented, one could have chosen to dispense or not to dispense, thus one should be provoked to consider potential reasonings for either option, such as travel, family, and so on.
