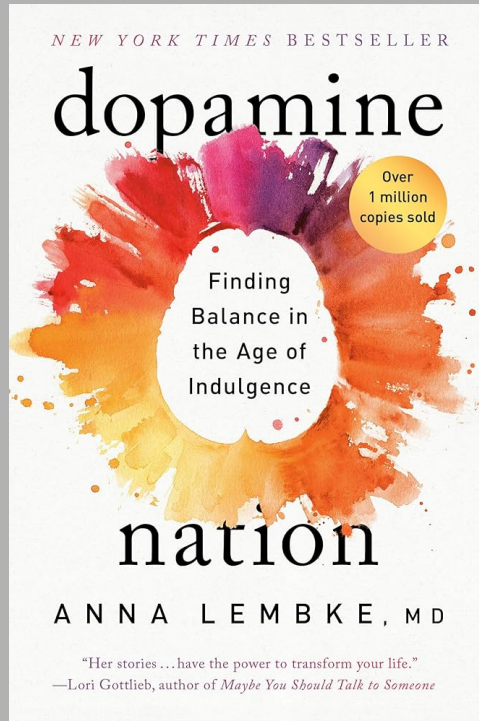

The NFL draft is right around the corner, yet this is not a play on words diminishing the incredible knowledge and expertise of healthcare professionals in matters involving controlled substances, rather a dive into propelling said folk to think deeper.

### **THE CASE**

#### **Acute Opioid & Benzo while utilizing Bup MOUD**

Thomas Payne has been picking up his prescribed and dispensed buprenorphine/naloxone 12mg/3mg exactly every 28 days for at least the past 6 months. He unfortunately suffered an injury resulting in intense dull pain, which propelled his care team to prescribe him oxycodone 5mg (1 tablet every 6 hours as needed for pain) #20 and Lorazepam 0.5mg (1 tablet prior to upcoming orthopedic surgery). He presents to the pharmacy today with both prescriptions.
