Red Flag Football: DEA Red Flag Case

The NFL season is just around the corner, yet this is not a play on words diminishing the incredible knowledge and expertise of healthcare professionals in matters involving controlled substances, rather a dive into propelling said folk to think deeper.

THE CASE

This is the follow-up commentary on the DEA Red Flag Case from the previous Pain Press Issue (Volume 2), which was also presented to a packed house (some folks were not allowed in after capacity was reached!) at the APhA 2024 annual meeting in Orlando, Florida.

The Dr.'s Garofoli (Gretchen & Mark) happily live together and attended APhA '24 in Orlando together. While frolicking in the conference hotel with their young boys, they hurt their backs and could barely walk without 12-out-of-10 pain. A local urgent care provided acetaminophen/codeine 300mg/30mg and cyclobenzaprine 10mg scripts to each of them. Sadly, they forgot an insurance card so they offered to pay cash at the pharmacy.

What "DEA Red Flags" +/- "General Controlled Substance Concerns" are involved in this case?

The potential controlled substance red flags involved in this case include: Sedative Drug Combination, Geography, Same Last Name and Same Address, & Out-of-Pocket Pay.

However, the intent of this case is to illustrate that not every potential controlled substance red flag results in a propensity to not dispense a controlled substance medication, while concurrently emphasizing that a dispensing pharmacy does always need to conduct due diligence to ascertain answers to respective controlled substance questions. Turns out, that sometime (documented) answers can certainly be allieviated resulting in the dispensing of medicaiton, even if multiple questions (red flags) exist, yet other times, the opposite can certainly be true as well.
