

#### **Red Flag Football: Controlled Substance Red Flags Case**

The NFL season just capped off with SuperBowl LIX, yet this is not a play on words diminishing the incredible knowledge and expertise of healthcare professionals in matters involving controlled substances, rather a dive into propelling said folk to think deeper.

#### **THE CASE**

A 45-year-old male patient presents to your pharmacy on a Friday night requesting to fill his prescription for hydrocodone/acetaminophen 10/325 mg (1 tablet four times daily) for chronic knee pain. Notably, he exhibits a mild limp while walking. He lives 20 miles from your pharmacy where he was running errands all day prior to driving to see a show with his Wife tonight. He sees a pain management specialist 120 miles from your pharmacy as he fully trusts his doctor and used to live closer to the office prior to moving to your town two weeks ago to be closer to his aging mother in need of family assistance. He states he has been utilizing the opioid for over two years and claims other medications and treatments, such as NSAIDs and physical therapy, "just don't cut it." He denies any history of substance use beyond an occasional bottle of beer during big games. The PDMP shows consistent, yet early, prescriptions from a single provider over the past 12 months, which he explains as "avoiding running out over weekends or holidays." Patient is polite and cooperative but exhibits consternation in his facial expressions when asked why he hasn't sought care closer to home. He reiterated that "finding the right doctor is more important than convenience", and he literally just moved. Additionally, the patient stated that he is readily willing to pay out-of-pocket (credit card for an intentional paper trail) if his insurance provider will not authorize the early fill.
