WHEN DO YOU NEED TO CONSIDER COMMUNITY ENGAGEMENT?

- Understanding the community risk profile by conducting a Risk Assessment is mandatory.
- You should be thinking about community risk when applying for a new exploration licence.
- A Community Consultation **Strategy is mandatory** through all stages of a project lifecycle.
- Land Access negotiations can begin when an ELA is submitted and are vital once your EL is granted.

The mandatory Community **Consultation Strategy** is about more than Land Access. You need to identify all your stakeholders, their interests and needs, risks, and the level at which you need to engage with them.
