# Pineo's Pet Spaw & A Dogs Day Inn GROOMING AGREEMENT

This agreement is between Pineo's Pet Spaw & A Dog's Day Inn (hereinafter referred to as "The Spaw") and the pet owner (hereinafter referred to as "Owner"), whose digital signature confirms their agreement to the following terms:

# **Authorization & Veterinary Care**

- 1. The Spaw has my permission to take any actions deemed necessary for the well-being of my pet.
- 2. If The Spaw determines that veterinary care is required, I authorize them to use a veterinarian of their choice.
- 3. I agree to cover all associated veterinary costs and release The Spaw from any claims related to such care.

# **Liability & Grooming Risks**

- 4. The Spaw is not responsible for any pre-existing conditions, illnesses, or ailments discovered during grooming.
- 5. If veterinary care is necessary due to grooming services, The Spaw must be notified within 48 hours.
- 6. Except in cases of gross negligence, The Spaw is not liable for any loss or damage to my pet.
- 7. The Spaw is not responsible for:
  - Clipper burn, minor nicks, or skin irritation from grooming.
  - Stress-related effects from grooming.
  - Issues resulting from de-matting/shaving, including itchiness, redness, or self-inflicted irritation.

### **De-Matting & Special Handling**

- 8. De-matting fees are based on the severity of matting and will be determined at The Spaw's discretion.
- 9. The Spaw reserves the right to refuse grooming for any pet due to health or safety concerns.
- Muzzles or other handling techniques may be used if necessary. (Additional costs will incur)

11. Grooming may be discontinued if a pet is deemed unsafe due to behaviour, health conditions, or parasites.

### **Owner Responsibilities & Liability**

- 12. I must **inform The Spaw if my pet has bitten anyone/animals** or has aggressive tendencies.
- 13. I am solely liable for any harm, injury, or damage caused by my pet.
- 14. I will inform The Spaw if my pet is prone to ingesting rocks, plants, or feces, and I release The Spaw from liability for any related issues.

# **Facility Policies**

- 15. Due to Kings County Noise By-Laws, a bark collar may be used for excessive barking (20+ minutes).
- 16. My pet may be allowed outside in designated areas for elimination.
- 17. I agree to notify The Spaw at least 24 hours in advance to cancel an appointment. Failure to do so will result in a rescheduling fee of 50% of the estimated grooming charge (minimum \$60). (Please Note: Monday appointments need to be cancelled no later than Thursday 6 pm, Friday cancellations for Monday appointments will incur additional cancellation charges)
- 18. Missed appointments will incur a fee of at least 50% of the estimated grooming charge (minimum \$60).
- 19. I will be punctual for drop-off and pick-up. A late fee of \$5 per 15-minute delay applies after the scheduled time.
- 20. I will ensure my pet has relieved itself before drop-off.
- 21. I affirm that I am the legal owner of the pet receiving services.

## Media & Acknowledgment

- 22. I acknowledge that The Spaw may use photos or videos of my pet for social media purposes.
- 23. I have read, understand, and agree to The Spaw's policies as outlined in this agreement.
