

Pineo's Pet Spaw & A Dogs Day Inn
DAYCARE & KENNEL REGISTRATION AGREEMENT

This is a contract between Pineo's Pet Spaw & A Dogs Day Inn (hereinafter called the "Company") and the pet owner whose digital signature is confirmed (hereinafter called "Owner").

1. The Owner specifically represents that he or she is the sole owner of the pet.
2. The Owner certifies that all information given about said pet is accurate.
3. The Owner specifically represents to the Company that the pet has not been exposed to rabies, canine/feline distemper, or canine cough within a thirty-day period prior to boarding.
4. The Owner agrees to be solely financial responsible for any and all acts or behavior of said pet(s) while the pet(s) is in the care of the Company – including but not limited to damages to property or other dogs.
5. The Company shall exercise reasonable care for the pet(s) delivered by the Owner to the Company for daycare, grooming. The Owner agrees that despite the efforts of Pineo's Pet Spaw & A Dogs Day Inn staff to provide a safe environment, there may be unpredictable or unforeseeable circumstances that may expose Owners and/or their pet(s) to health risks or injury. The Owner hereby waives and releases Pineo's Pet Spaw & A Dogs Day Inn., it's employees, owners and agents from any claims while Owners and/or their pets are on the property.
6. The animal will be allowed outside to eliminate in rock and or grassed yards. I agree to inform **The Spaw** if the animal is known to ingest rocks, outside plants and/or feces and The Spaw will not be held responsible for harm of the animal due to ingesting without notification.
7. If the pet(s) becomes ill, or the state of health or well-being otherwise requires professional attention, the Company, at it's sole discretion, may engage the services of a veterinarian or administer medicine or other requisite attention to the animal, and it is agreed that all costs and charges thereof shall be paid by the Owner.
8. The Owner agrees to pay all costs and charges for services he/she requests.
9. All charges incurred by the Owner shall be payable at the time the pet(s) is discharged from the Company.

10. For long-term boarding arrangements, the Company, at its sole discretion, may require a deposit before agreeing to provide services. The Owner agrees to pay such deposit, as required.
11. Owner understands and acknowledges that from time to time, for the purpose of training, and/or advertising and/or promoting its business, the Company takes photographs of its employees and programs, including pets on site. In consideration of the Company's agreement to accept Owner's pet for participation in its programs Owner hereby releases from liability and licenses to Company the right to use any photos of or including Owner's pet for any lawful purpose(s) including training materials, advertising and/or promotional materials.
12. I understand that if I am late picking up my pet I will be charged \$10.00 for every 30 minutes that I'm late (Any time after 5:30pm – without notifying the Spaw).
13. This Contract is binding for the present and all subsequent engagements for services of the Company by the Owner.
14. The **Spaw** is located in the heart of the Centreville community and for those dogs that constantly bark for more than 20 minutes, due to Kings County Noise By-Laws, a bark collar will be used periodically. For dogs that dig, chew and attempt to escape, they will be placed in 20 minute time outs and if the behavior continues, will be asked to leave.
15. This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assignees of the Owner and the Company. This contract is entered into and shall be interpreted under the laws of the Province of Nova Scotia. Owner agrees to submit to the jurisdiction of only the Nova Scotia Courts with respect to any dispute relating to this agreement and/or the Owner or Owner's pet's relationship with the Company.

I hereby acknowledge that I have read all of the above and agree as the Owner of the animal(s) foregoing.
